Approval of this purchase will allow for the following installations: <ol style="list-style-type: none">1. two wall-mounted stations at Hamilton Elementary School (in the cafeteria and 400 Building)2. two wall-mounted stations at Hamilton High School (in Ms. Mello's classroom and the Gymnasium),3. one free standing station at Hamilton High School Stadium HSUD received CDE approval for this proposed capital expenditure on May 3, 2022.
