Dear Board Members,

I want to inform you about a distressing situation regarding Ms. Marion. On Sunday, November 6, we learned that she was in critical condition and had been transferred to the ICU, where she was given only a 5% chance of survival. Unfortunately, we received the news of her passing during our board meeting on the 7th, which deeply saddened us all.

While this news is only informative, I also wanted to share additional news that has been brought to my attention. Ms. Tracy has shared with me the funeral arrangements that have been made for November 22nd, this Friday. As a result of creating such an integral impact on our community, ten teachers have called out to support Ms. Nether during this difficult time. So far, the administrative team has committed to being in attendance.

This is what is on the table:

As a Board, one of our commitments is to maintain fiscal responsibility and make decisions to safeguard our AACCS community. If ten teachers are absent, the substitute teachers brought in would charge for a full day of service for each, resulting in a significant cost. I have inquired about the impact this may have on parents who use Innovation Learning as their daycare service. I have found out that they require a certain number of families to register, and due to the associated costs, they often struggle to achieve sufficient enrollment.

I recommend establishing a grievance day for our community, considering the possibility of more teachers calling off work. Reflecting on our mission statement and strategic planning meetings, we aim to focus on the well-being of the whole child. However, we cannot achieve this goal without ensuring a stable presence of our teachers.

Moving forward:

As a facilitator of this emergency, I would need a motion on the table and a second.

Once there is a second, we can ask questions or make comments

reflecting the motion. (if there is no motion or second to the motion, no discussion can be had). If no questions or comments exist, a separate email will be sent for voting.

All discussions will be posted to the website (including this thread) for transparency.

If a motion is proposed, some important factors to consider are the date, the grounds or motives behind it, and the procedures involved. Will the president of the board, in collaboration with the principal, be responsible for informing teachers and parents?

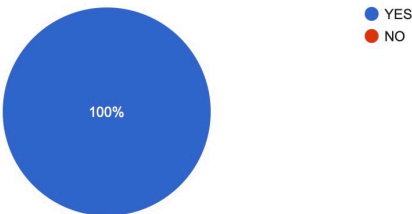


