Kev ua kom muaj cov phau ntawv qhia thiab cov ntaub ntawv qhia zoo rau txhua tus menyuam kawm ntawv, no los yeej yog hais txog cov menyuam kawm ntawv Askiv yog horn thib ob, yuav tsum muaj cov phau ntawv qhia los sis cov ntaub ntawv qhia coj los siv nyob rau hauv chav qhia ntawv thiab hauv tsev. Cov ntawv qhia:

Qib K-12: Ntawv qhia Askiv, Lej, Keeb Kwm/Kev Noj Nyob, Science

Qib 7-12: Ntawv qhia txog lwm horn lus

Qib 9-12: Kawm Science muaj cov khoom siv (Laboratory Science Equipment)

2. Tsev kawm ntawv yuav tsum huv, puaj phais, thiab zoo khov kho. Cov chav dej siv yuav tsum muaj txaus rau cov menyuam kawm ntawv kom huv siab si, khaws cia tej ntaub siv thiab siv ua haujlwm kom tau zoo.
