To the Great Falls Community,

Did you know that you have the incredible opportunity to directly impact the education of students in our community through the *Innovative Education Tax Credit* for Great Falls Public Schools? The state allows you to redirect a portion of your taxes directly to our school district instead of to the State, empowering us to enhance educational programs that significantly benefit our students' learning experiences.

The 2023 Legislature enhanced this program (HB 408), making it more impactful than ever before. By participating before the deadline of Wednesday, January 15, 2025, you'll receive a dollar-for-dollar tax credit on your State income tax bill in 2025.

Your contribution will support innovative educational initiatives, primarily focusing on adaptive equipment expanding opportunities for children with disabilities with technological enhancements and work based learning partnerships.

These funds will directly benefit our students by providing:
Transformational and advanced learning opportunities, programs,
services, and equipment for students with disabilities, work based
learning partnerships, post-secondary credit or career certifications
and technologies that improve student experiences and opportunities.

"The Innovative Education Program is an exciting opportunity for taxpayers to make a big difference in the lives of our students by directing their tax dollars to the Great Falls Public School District. If we come together as a community, we can steer up to \$1 million to the students of Great Falls at minimal cost."

This opportunity operates on a first-come, first-served basis. In 2022, the \$1 million credit was claimed in less than six minutes, and in 2023, most of the \$2 million was claimed immediately. Please note the following caps: Individuals or corporations can donate up to \$200,000 per year for our school's innovative educational programs. The statewide aggregate amount of tax credits claimable in 2025 is \$6,250,000.

Moreover, this program allows for a carryover of tax credits for up to three years for doners. Upon participation, you will receive a confirmation number and receipt to include when filing your 2025 taxes.

We highly encourage you to consult your financial planners or advisors before participating in this

program.
