- The Board President will call on the person who signed up to speak during Public Comment to address the Board. They will have no more than three minutes to make an oral presentation.
- Speakers who read from a prepared text are encouraged to present copies of that text to Board members prior to speaking, or to the District Clerk within 24-hours after the meeting.
- Members of the Board will listen to remarks of speakers, but no action or discussion will take place at this meeting.

The Board of Education is comprised of seven representatives elected at-large by qualified voters of the school district. Members are elected to staggered three-3 year terms. It is the duty of the Board to set policy which provides for the quality education of students. Medina School Board members give freely of their time, they are not paid. Officers of the Board are elected annually at a reorganizational meeting held in early July.

## Board Action

The Board of Education is a policy-making body. All actions of the Board are made within the confines of the laws of New York State, the federal government and the Regulations of the NYS Commissioner of Education. Board actions include approval of budget and expenditures, personnel appointments, and a variety of items related to the operation of the District and the determination of educational goals and standards. Action can be taken only when a majority of the Board members are present.

At times, the Board will go into Executive Session to discuss matters of personnel, negotiations or legal matters. Executive Sessions are not open to the public and no action is taken by the Board during Executive Session.
