DATA GOVERNANCE UPDATES



■ Texas First Early High School (SB 1888):

- During the 87th legislative session, SB 1888 was passed, which amends TEC§ 28.0253. As a result, the Texas Education Agency (TEA), in coordination with the Texas Higher Education Coordinating Board (THECB), established the Texas First Early High School Completion Program. A student who graduates early through the program is considered to have earned a diploma with a distinguished level of achievement under TEC §28.025. The school district must provide each student who earns a program diploma with a designation of distinguished level of achievement on the student's diploma.
- After passing SB 1888 during the 87th legislative session, students now have two paths to earn a diploma with the distinguished level of achievement designation. Before SB 1888, a student only earned a distinguished level of achievement under the foundation high school program by successfully completing the requirements as outlined in TEC 28.025 (b-15). After SB 1888, when a student earns a diploma under the Texas First Early High School Completion Program (TEC 28.0253), they automatically receive the distinguished level of achievement designation.



DATA GOVERNANCE UPDATES



- **Texas First Early High School (SB 1888):**

- During the TSDS Upgrade Project, TEA separated the data element FHSP-DISTING-LEVEL-ACHIEVE-INDICATOR-CODE (E1542) into two data elements. In the TSDS Upgrade Project, TEA uses the data element FHSPDistingLevelGraduate (E1542) to indicate a student has earned a designation of distinguished level of achievement and FHSPDistingLevelParticipant (E3029) to indicate the student is pursuing the distinguished level of achievement under FHSP. The program area has requested replacing the data element FHSPDistingLevelGraduate (E1542) with a more generic data element, to indicate the distinguished level of achievement has been earned since it can be awarded through the Foundation High School Program or the Texas First Early High School Completion Program.
