Member moved the adoption of the following Resolution: Resolution Authorizing the Fund Transfer of \$13,663 from the District's Unassigned Fund [422] to the Restricted ECFE [432] In Addition This Resolution will Authorize the Transfer of \$53,890 from Unassigned Fund [422] to Restricted Reserved for School Readiness [444]. This Fund Transfer is Eliminate a Deficit.
Now Therefore, be it Resolved by the School Board of Independent School District No. 0414, State of Minnesota, as follows:
 The Board hereby determines that the amount of \$13,663 shall be transferred from the District's Unassigned fund [422] to Restricted Reserved fund for ECFE [432] and the amount of \$53,890 shall be transferred from Unassigned fund [422] to Restricted Reserved School Readiness fund [444].
 The Board hereby affirms that said transfer will not diminish instructional opportunities for students and is for the purpose of eliminating a deficit in Operating Fund 04.
