Jim Kelley Career Pathway Center Update Jesse Webb, Director of Career & Technical Education gave a Jim Kelley Career Pathway Center Update, along with a video highlighting the activities that middle school students explore as they connect to high demand career fields that are available right here in Allen County. These students experience a glimpse of the skills needed to be successful in those career fields and spark interest in pursuing the pathway of their choice within our Schools of Success. This update also touched on the 6th grade experience and how staff are able to experience this program as well.

Comments

Board Member Steve Corona shared his story of when he visited the Jim Kelley Career Pathway Center last year and attempted to do a virtual oil change. Member Corona also shared that he will be participating in this week's Principal for a Day with other community members.

Board Member Antonette Payne is also looking forward to this week's Principal for a Day. Member Payne also shared that she enjoyed attending IREAD celebrations and congratulated schools for their improvement. She hopes that staff and families enjoyed fall break.

Board Member Julie Hollingsworth spoke about ProPublica's study regarding Arizona's universal voucher, which was sold as "saving money." This program did not consider parents already in private schools who were already paying full price tuition. This study looked at zip codes and family income of the students and they found that the vouchers were used less in the lower income zip codes and had more use in zip codes of higher income families. More students of wealth were being covered. Even though the voucher lowered the tuition cost for lower income families, it didn't take into account other expenses like having to transport their own children. Member Hollingsworth warned that we need to pay attention to Arizona as Indiana legislators are considering the same type of program. Not good public policy, if good it would help all students and build the workforce, this is not accessible to all students. Ms. Hollingsworth also congratulated South Side girls for beating Snider in the very first flag football championship in Fort Wayne.

Board Member Noah Smith spoke about the recent voucher article in the Journal Gazette and the shortfall of Medicaid funding. Member Smith is also looking forward to this week's Principal for a Day. He also congratulated South Side for winning by one point over Bishop Luers football last weekend. Mr. Smith also congratulated South Side girls for their flag football win.

Board Member Jennifer Matthias also congratulated South Side girls for their flag football win. Member Matthias also stated that she is looking forward to this week's Principal for a Day. She also recommended the community read the Journal Gazette article that Mr. Smith mentioned. Ms. Matthias reported that she has been studying enrollment since vouchers, and private school enrollment is declining. Member Matthias stated that even with our budget constraints, we are being good stewards, we publicize our budget and we are doing the best we can in educating our students. She encouraged the public to pay attention and step up.

Superintendent Dr. Mark Daniel, announced that Senator Raatz, Chairman of the Education Committee, will be participating in Principal for a Day. While in the district, he would like to have the Senator attend other programs. Superintendent Daniel also announced that Ramona Coleman has just past her dissertation and she is now a doctor. Dr. Coleman took the time and thanked those that helped, including her family. Her dissertation was on the perception of professional learning in the South Bend School District. Dr. Daniel also asked Rosie to speak. Ms. Shipman announced that since 2018 we have

tried to up our Standard & Poor term rating from an A+ and we have now been upgraded to AA- as we increased our enrollment, because we are 99% dependent.

Board President Maria Norman congratulated Ramona for achieving her doctorate. President Norman is also looking forward to this week's Principal for a Day.
