#### **MINUTES**

The Campbell County Board of Education building Committee met on Monday, September 30, 2024, at 5:00 p.m., in the lower-level conference room of the Central Office. The following committee members were present: Ryne Cummins, Brandon Johnson, Ronnie Lasley, Brent Lester, Jamie Wheeler, and Chairman Jeffery Miller. Director of Schools Jennifer Fields was present, and Gail Parks kept the minutes.

III. Recognize Lewis Group Architects (Update on Jacksboro Elementary Gym/Cafeteria Expansion – Questions/Answers).

Jacob Thomas with Lewis Group updated the committee on the project. When the brick was removed it created a crack within the wall, they are temporarily doing a shoring to do a quick fix. Mr. Stan Marlow stated the company pulled the brick. Board member Cummins asked if this was new, and Mr. Thomas stated yes and can be repaired as new with concrete. Board member Johnson requests a spot check for other cracks or damage through the building for safety purposes. Safety is #1 priority. Chairman Miller asked in the event the trac did this damage who is responsible. Mr. Thomas stated he would let him know. This Thursday will be trenching foundation 300 days approximate from start date.

IV. Recognize Weeks Ambrose and McDonald Architects (update on CCHS upper weightroom repair and New Auxiliary Gymnasium/Questions/Answers).

Mr. McDonald updated by informing finishing documents currently and looking at 15% increase from July due to things being added. The cost has remained stable, but the hurricane will cause impact. The slab in weight room entire replacement has gone from \$115,000 to \$150,000, 1.375 million to 1.565 million for the auxiliary gym. Chairman Miller asked what time from for completion of the weight room. Mr. McDonald replied 3 months possible weather permitting.(March). Board member Lester asked if there was any way possible to expedite this project so the students can get in. Chairman Miller stated his project is priority. Stan Marlow informed the guttering inside the building has been leaking for a long time. Chairman Miller stated this was brought before the board in January 2024 and the board voted it down.

A community guest Mr. Kirby, spoke and said that kids were getting hurt, and the board had failed the student athletes and they have been neglected. A coach was brought in here from Rhea County and promised things. Mr. Kirby stated Chairman Miller had fought this tooth and nail and it was a fact. Cody Graham asked if this could be considered an emergency. Director Fields stated this had to go through the bid process. Coach Pemberton stated Chairman Miller has

worked diligently with him and he appreciated this. He stated we need this ready for January. This needs to be a priority and let's move forward for our kids. The architect will do everything to expedite this.

V. Update on Capital Outlay Projects approved in 24/25 budget for Caryville Elementary, Jacksboro Middle, Valley View, LaFollette Middle, CCHS Exterior Doors, Wynn Elementary.

Traci Chambers gave an update on the projects. Caryville Elementary has 3 quotes for playground equipment and awning request has been complete, Caryville Elementary scoreboard, re-sealing and striping and parking lot signage estimated cost of \$130,000. Jacksboro Middle Lockers, library flooring, updates to football fieldhouse estimated cost \$100,000.JHS van estimated cost \$50,000.\$10,000 each for JMS and LMS weights. Exterior doors at CCHS \$100,000 for four years. Wm. S. Trimble will be here on Wednesday to look at the doors. Buy Board is a possibility. Band is getting quotes and additional quotes are needed for playground chips.
