Family Involvement Policy:

The Title 1 Family Involvement Policy at Alma Redwine sets the expectations and establishes the framework for parental participation. Our policy is designed to supplement the effectiveness of the school-wide Title 1 plan through effective family involvement.

- ❖ Hold annual meeting at convenient times for the purpose of keeping parents informed about our school's participation in Title 1 and their right to be involved in school planning as well as their child's education process
 - Parent-Teacher Conferences held as scheduled on the 2023-2024 school calendar and as requested by the parent or teacher
 - Meetings concerning high stakes testing are provided annually
- ❖ Offer a flexible number of meetings as follows:
 - Monthly School-wide planning meetings
 - Parent workshops that give parents valuable information to assist in their child's learning
- ❖ Involve parents in an organized, annoying way in the planning, review and improvement of Title 1 programs.
 - Monthly newsletters
 - Notes are sent home frequently to communicate with the parents about events at our school
 - Workshops/In-services
- ❖ Provide parents with their child's required school performance profiles and assessment results including interpretation of the results
 - LEAP
 - Accelerated Reading (1-5)
 - School Report Card
 - Progress Reports

- ❖ Provide parents with a description of the curriculum in use and the forms of assessment used to measure student progress
- ❖ Develop with parents a home-school compact that would involve the student, teacher, and parent
 - Parent-Teacher-Student Compacts
 - Parent-Teacher conferences as scheduled
- ❖ Hold parent conferences regularly
 - LEAP workshop
 - Parent-Teacher conferences as scheduled
- ❖ Provide assistance to parent in interpreting and understanding the current State Content Standards and benchmarks
 - Parent workshops
 - Provided description of the current curriculum and methods of assessment
 - Frequent communication between school/teachers/parents
- ❖ Report frequently to parents about their child's progress
 - Daily reports sent home in student folders
 - Weekly papers sent home on Tuesdays
 - Progress reports sent home every fourth week of the each nine week period
 - Report cards sent home every nine weeks
 - Individual Parent-Teacher conferences when necessary
 - Parent access to online portals to view student progress
- ❖ Provide opportunities for parents to volunteer in the school
 - Parent volunteers for classroom or school activities
 - Implementation of parent-teacher organization
- ❖ Develop appropriate roles for community-based organizations
 - Local business activities
 - *Sonic: Student incentives/ Sonic card fundraisers/donations
 - *Coca Cola: Fundraisers/donations
 - Fire Prevention
 - D.A.R.E
 - Fire Safety: Alexandria Fire Department
- ❖ Ensure, to the extent possible that information related to school and parent programs are sent to the home of children in the language used in the home.
 - Assistance provided by the Migrant and ESL programs advocates
- ❖ Arrange for teachers and/or other educators to conduct in-home conferences for those parents unable to attend the school meetings
 - Receive assistance from the Home-School teachers as needed
- ❖ Reserve at least 1% of the Title 1 allocation to Alma Redwine for family involvement activities
 - Take-home educational resources are available for parents to check out on an as-needed basis
