3. Council Action and Review Items.
 - a. Review of OVEC Contract. Mr. Caldwell explained to Council that the Chinese Teaching positions in our building are through OVEC not the OC District.
4. Principal Update.
 - a. Update on KSA data/iReady Diagnostic. Mr. Caldwell said KSA data will be released for the next meeting. He explained iReady in that it had replaced the MAP testing last year. It is a schoolwide reading and math program that uses 5 levels of proficiency for diagnosis. He reviewed level and percentage rates with Council.
 - b. REP Plan for 1st Semester. We will be changing our REP classes to have a more focused purpose on our reading as it affects every subject.
 - c. Update on PTO. The PTO now has their officers set. They have approved their ByLaws and are applying for their 501C status. They have received Certification and an EIN Tax Number. They will be working on Secret Pals, Snack Days and a Dance possibly for November.
 - d. Board Showcase. OCMS will be performing at the Board on October 14th. We will be highlighting our music program and the Choir will be singing and have a presentation. The SBDM Council will have their annual presentation to the Board on January 16th.
