# Dear East Islip School Community,

We are reaching out to share an important development that could significantly impact the future of our school district. Recently, the New York State Education Department (NYSED) introduced a "Regionalization Plan" that may alter East Islip School District's structure and identity. This plan was set forth as an Emergency Regulation in the NY State Register on September 25, 2024. In response, the East Islip Board of Education, along with our administrators' and teachers' bargaining units, have sent a letter of concern to the Commissioner of Education, expressing our serious reservations and opposition to the plan. The letter will be posted on the district's website.

# What is the Regionalization Plan?

The Regionalization Plan is a state-mandated proposal requiring school districts to consider consolidations and resource-sharing with neighboring districts, enforcing a global model with no option to opt out. Our primary concerns include:

- Loss of Local Control: This plan could shift decision-making authority away from our locally elected Board of Education, instead placing more control with a BOCES superintendent. This change would reduce our district's autonomy in making decisions that reflect East Islip's unique needs.
- Impact on Classroom Resources: Regionalization could mandate the acceptance of students from other districts, potentially straining classroom resources and affecting class sizes, which could alter the quality of education our students currently receive. However, there has not been any clear guidance as to how this will be accomplished.
- **Data Reporting Requirements:** The plan currently imposes extensive reporting requirements on our district, diverting resources away from direct support for students and teachers. They have asked the districts to respond to a 40-page survey with information they already have available to them.
- Lack of Transparency on Financial and Governance Implications: Limited information has been provided on how this plan might impact East Islip's financial health and governance structure, leaving critical questions unanswered.
