VIII. Review Measure O Expenditures

The committee reviewed the measure O expenditures from series 2017A fund 2104, series 2019B fund 2107, series 2020C fund 2108, series 2020D fund 2109 and series 2020E fund 2110. Naripjeet Josan had questions about the balances and rolls over, such as, do the balances roll over or do we lose the funding. Clarification was provided, explaining the process and giving updates on the projects and the funding/balances for those projects. The funds do roll over, but bond funds do need to be exhausted by a specific year and the district was going to look into that and provide the details at the next bond meeting.

IX. Review Measure L Expenditures

The committee reviewed the measure L expenditures from bond Series 2022A, fund 2111. The committee asked about the projects with no expenditure reflected on the spreadsheet and the district explained the project(s) is forecasted for the future and all expenditures are still being added / encumbered for this fiscal year. The committee recommended a pool cover the for Selma High School Pool Project.

Betty Alves asked if we have site maps showing construction at all the sites. Can we have

the site maps showing past, current and future construction to allow the sites and parents an idea of what changes happened or will happen.
