Background

- School Districts are required to submit a First Interim Budget to their County Office of Education (COE) by mid-December every year
- First Interim Budget is assigned either a Positive, Qualified, or Negative Certification by the COE
 - Positive: the district will meet its financial obligations (positive balance with 3% State required minimum reserve) for the current fiscal year and subsequent two fiscal years
 - Qualified: the district may not meet its financial obligation for the current fiscal year or two subsequent fiscal year
 - Negative: The district will be unable to meet its financial obligations in all three years
- 2023-24 First Interim Report for MPESD is positive.



Update on State Budget (shared by SSC*)

Structure of the 2023-24 Enacted State Budget

- The 2023-24 Enacted Budget solved a \$26.5 billion budget problem, \$22 billion of which was caused by revenue declines compared to June 2022 expectations
 - A \$14 billion deficit is assumed in 2024-25—could get better or worse with actual revenues and expenses!
- Postponement of personal income tax and corporate tax returns until October (and then November) makes this year's Budget the riskiest in a decade



- Reliance on one-time revenue to pay for an ongoing cost-of-living adjustment (COLA) increases risk to future budgets
 - One-time grant programs that local educational agencies (LEAs) have planned on have been reduced in the Enacted Budget as compared to both the Governor's Budget and the May Revision
 - At Enacted Budget, the Department of Finance projected 3.94% COLA for 2024-25

3 How Are Revenues Faring Since Budget Enactment?

- Relative to the revised estimates included in the 2023-24 Enacted Budget, state revenues beat projections by \$980 million for the 2022-23 fiscal year
- Thus far, 2023-24 revenues are on target with monthly projections
 - July preliminary General Fund cash receipts: More than \$1.2 billion below the 2023-24 Budget Act forecast
 - August preliminary receipts: \$1.344 billion above the forecast
 - September preliminary receipts: \$796 million above the forecast
 - So far, receipts for the first three months of the 2023-24 fiscal year were \$879 million, or 2.4%, above the forecast

District Budget

Revenue Factors

- LCFF: effective 2022-23, school-district-funded ADA for the LCFF has changed from the greater of current or prior year reported ADA to the greater of current, prior, or the three most recent prior years' ADA. This change has benefitted the district by receiving additional funding of 146.68 ADA in 2023-24. That has saved some of the district purchase power over the declining enrollment crisis.

District Budget

- The district estimated a 6% decline in enrollment at budget adoption. CALPAD enrollment is updated to be a 5.94% decline. Final certification of the enrollment number will be shared with the Board in the Second Interim.
- The Learning Recovery Emergency Block Grant's original allocation was \$2,851,123. The enacted budget confirmed the 14% cut. That was a \$408,107 reduction for our district. We had booked the deduction at the 2023-24 year-end closing. The district is not at risk of spending the funds that we didn't have.
- The District negotiated settlement with the Certificated Bargaining Unit was not approved by the end of the first interim, so it is not included in the First Interim Expenditures section. The Certificated Unit received a 5% increase on the salary schedule plus \$1,500 in each salary schedule cell, totaling a 6.5% increase in salary and an increase of \$2,000 in the benefit cap.
- The Classified and Management Bargaining Units have not yet settled.

Multi-year Projections

General Fund Unrestricted/Restricted

Budget Assumptions for Fiscal Year 2024-25 and 2025-26

- LCFF Revenue: estimated 6% decline in enrollment in the two subsequent years
- Add 1.5% step & column increase
- Benefit costs were budgeted with the increase in PERS, STRS
- Projected a 4% reduction in services and operating cost
- Certificated Bargaining Negotiation was settled after the First Interim cut off. The cost was not included in the operating expenses in 2023-24.
- All of the one-time restricted resources have the allowable usages and timelines that the district has to follow when spending the funds
- In 2024-25, one-time and restricted revenues reduced \$1.02 million from the State funds, \$1.54 million in Federal funds, and \$375 thousand from the Local funds. Total reduction of 2,941,007 in restricted funds.
- At the State Enacted Budget in July, the proposed COLA for 2024-25 was 3.94%. On November 16, the Fiscal Report from School Services of California stated that "... the likelihood of it being 3.94% appears to be slim to none."
- In mid-November, the County advised the LEAs to use different scenarios to estimate the best for the district. We used 2% in our First Interim Report.
- In early December, SSC advised that the COLA could decrease to as low as 1.29%.
- The final statutory COLA won't be known until April 2024. The constant economic changes make it more difficult for the districts to budget accurately in these uncertain times.
- The administration will bring the updated information to the Board in January after the Governor releases next year's state budget.

Part IV - Carry-forward Adjustment
