 - *the carrying out of other activities, such as those described in section 1118 of the ESEA.*

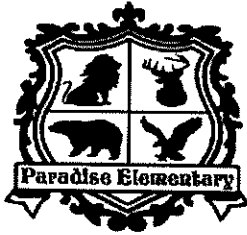
PART I. GENERAL EXPECTATIONS

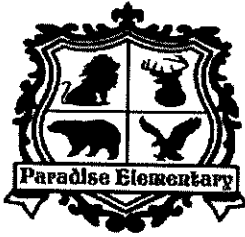

3. Paradise Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
 - a. Flyers will be sent home
 - b. The meeting will also be publicized on social media and our school calendar
4.  - a. Letters will be sent home immediately if this situation arises.
