Policy #5

Assessments and Examinations

The purpose of examinations is to help students' parents/guardians and teachers identify each student's educational performance, growth and areas needing improvement in order to enhance teaching and learning. Examinations of student progress are based on numerous measures of student performance that provide a thorough evaluation and therefore, an extensive scope of the student's learning.

Examinations Required by the State Government

The charter school students shall participate in all state and federal required examinations. Such examinations provide the charter school with information for evaluation and future planning. State examinations also indicate the charter school's effectiveness in carrying out its educational mission.

Whenever examinations required by law are administered, the Executive Director of the charter school or his/her designee shall provide parents/guardians written notice of the date of the examination, the uses and importance of the examination, and the student's test results.

All examinations required by the state law will be administered according to law on the dates required by law.

Special Education students shall participate in state examinations according to their Individualized Education Program.

Parents/guardians may obtain for their student an exemption from the state examinations only by written request sent to the Executive Director of the charter school or his/her designee.

Academic Grading

Student progress evaluation provides information on student learning and where the student needs improvement. Parents/guardians are integral to student educational accomplishments. Therefore, parent/teacher conferences will be conducted as indicated on the Master Agreement. Parents/guardians will receive report cards indicating their student's educational progress. Parents/guardians will be notified of deficiencies in their student's educational program.

At parent/teacher conferences, parent/guardians will be informed as to the goals and objectives of each course, grading procedures for academic grades, classroom practices and procedures, and parent/guardian responsibilities.

Teachers are responsible for setting objective standards for grading academics and shall make these standards known to the parents/guardians. Teachers are responsible for assigning grades to the students in their courses. In the absence of fraud, mistake, bad faith or incompetence, the grade shall be final. A grade change may not be made as the result of coercion by any person(s).

Students will receive a grade after demonstrating adequate progress in the course. In the TK-8 programs, students who disenroll within three weeks of enrollment will receive a "No Grade" (NG). For students in grades 9-12, a "No Grade" (NG) will be assigned if they withdraw from the course within one week of the course start date.

If a student or parent/guardian believes a grade is unfair or inappropriate, the student or parent/guardian may appeal to the teacher of the class. If the issue cannot be resolved with the teacher, the student or parent/guardian may request a meeting with the Executive Director. Any meeting with the Executive Director and student or parent/guardian shall include the teacher who assigned the grade in dispute.

If the matter is still unresolved, the student or parent/guardian shall appeal in writing to the Board. The appeal shall allege specifically how the teacher's grading system reflects fraud, mistake, bad faith or incompetence.

The Board shall make every effort to receive input from the teacher who assigned the grade. The Board reserves the right to authorize the change of a student's grade based on error or miscalculation.

The decision of the Board shall be final and binding.

Policy #16

Alternative Pathways Toward High School Graduation for Students with Disabilities

Prescribed Course of Study

Pacific View Charter School's (PVCS) governing board recognizes that students with disabilities are entitled to a course of study that provides them with a Free Appropriate Public Education (FAPE) and that modifications to PVCS's regular course of study may be needed on an individualized basis to provide FAPE. In accordance with law, each student's Individualized Education Program (IEP) team shall determine the appropriate goals, as well as any appropriate individual accommodations and plan necessary for measuring the academic achievement and functional performance of the student on daily instruction and state- and district-wide assessments. The IEP team shall also determine the appropriate graduation track for each student with a disability based on the level of individualized accommodations and modifications documented in the IEP.

Pathways Options:

1. **Alternative Diploma Path**
2. **Certificate of Completion**

Alternative Diploma Path

Students with exceptional needs, who entered ninth grade in the 2022–23 school year or later, can graduate from high school with a diploma through this Alternative Diploma Path by meeting the following criteria as referenced in the student's individualized education program:

1. The student is eligible (*eligible*, but not necessarily taking) to take the California Alternate Assessment, and
2. The student is required to complete state standards-aligned coursework to meet statewide course requirements.

Courses required to meet the Alternative Diploma requirements may be modified (Functional) or unmodified (Foundations/Traditional) as determined by the IEP. Students are offered 220 credits, however only 130 credits are required to receive the Alternative Diploma.

Alternative Diploma Course Requirements:

English	30 credits
Math	20 credits
Biological Science	10 credits
Physical Science	10 credits
Social Science	30 credits

Foreign Language or Visual Arts	10 credits
Physical Education	20 credits

Certificate of Completion

Pacific View Charter School may award a certificate of completion, instead of a high school diploma, if a student with an IEP has minimally met one of the following requirements:

1. Satisfactorily completed a prescribed alternative course of study approved by the board of the LEA which has jurisdiction over the student as identified in his/her IEP; or
2. Satisfactorily met his/her IEP goals and objectives during high school as determined by the IEP team; or
3. Satisfactorily attended high school, participated in the instruction as prescribed in his/her IEP, and met the objectives of the statement of transition services.

Certificate of Completion Course Offerings: ~~Alternative Course of Study requirements are as follows:~~

Functional English	40 credits
Functional Math	30 credits
Science	20 credits
Social Science	30 credits
Foreign Language or Visual Arts	10 credits
Health	5 credits
Physical Education	20 credits
Electives	55 credits
Career/Technology	10 credits

Any of these courses may be waived as determined through the IEP process in alignment with the requirements of the Certificate of Completion Pathway.

Pacific View Charter School shall ensure a student with disabilities who meets any of the criteria specified above shall be eligible to participate in any graduation ceremony and any school activity related to graduation in which a graduating student of similar age without disabilities would be eligible to participate. In addition, Pacific View Charter School shall ensure that the student may continue to have access to special education related supports and services until the student meets Pacific View Charter School's diploma or certificate requirements, until age 22.
