SCHOOL BOARD MEETING

TIME/PLACE: A meeting of the Douglas County School District No. 4 Board of Directors was convened on Wednesday, October 9, 2024, at 6:00 p.m. in the Winchester Elementary School Library, 300 Page Road, Winchester, Oregon, in person and available via Zoom link.

CALL TO ORDER / PLEDGE OF ALLEGIANCE: Board Chair, Andrea Miner, called the regular meeting to order at 6:00 p.m. and invited Director Steve Hammerson to lead the Pledge of Allegiance. Chair Miner also advised the audience that Board meetings are recorded for future viewing and to please silence their cell phones. Anyone wishing to be part of Public Participation was asked to complete a card at the entrance to the room and cards will be collected prior to Public Participation. Our Zoom link is available for family and friends unable to attend the student and staff recognitions. No media representatives announced themselves.

Chair Miner introduced Winchester Principal Meghan Pirtle. We appreciate Meghan and her staff for hosting our Board meeting tonight and sharing the student artwork.

PRINCIPAL REPORT

Winchester Elementary School Principal Meghan Pirtle is in her third year serving as principal after having previously taught at the school. Student assessment numbers are being addressed through goals specific to

literacy, math and path to graduation. The instructional staff are digging into assessments to drive instruction by utilizing:

Principal Pirtle thanked the board for visiting the school and allowing her to be a part of Roseburg Public Schools. The Board appreciated the tour prior to the meeting, and Chair Miner thanked Meghan for her report.

STUDENT REPRESENTATIVE REPORT:

Roseburg High School leadership students Spencer Bingham and Sylvia Eckman announced that this year's Homecoming theme is "Miami Nights". Events will include the Powerpuff tournament, dress-up days, lunch time activities, the assembly, homecoming court, bleacher bum themes and of course the dance. Kate Miller was nominated to represent students on the Behavior Team that focuses on improving student outcomes through positive reinforcement. That team has reported that 63% of students believe there is decreased cell phone use in classrooms. Principal David Vickery is making himself available to students during scheduled "Lunch with Mr. Vickery" opportunities. Club grants are being made available to all student-led clubs on campus. Most recent sports results were reported and winter sport practices are beginning. Representatives from over 50 colleges were available to students at the Douglas County College Fair today. REPORTS

DIVISION 22 STANDARDS ASSURANCES – REPORT FOR THE 2023-24 SCHOOL YEAR

Assistant Superintendent, Michelle Knee, presented the district's Report on Compliance with Public School Standards for the 2023-24 school year, explaining that district superintendents are required by OAR 581-022-2305 to report to their community no later than November 1 each school year their district's status with respect to all of the Standards for Public Elementary and Secondary Schools. The standards are adopted by the State Board of Education and set out in Oregon Administrative Rules Chapter 581, Division 22. Michelle pointed out that compliance with these rules ensures a baseline level of service across the state. The Division 22 Standards articulate the floor of the education to be provided to students, not the ceiling, and compliance is tied to state school monies.

Asst. Superintendent Knee was happy to report that within the specific categories including Teaching & Learning, Health and Safety, District Performance and Accountability, and Human Resources/Staffing, the district was determined to be in compliance. She provided information on how to access resources for further information such as ODE's Rules at a Glance Summary, the Secretary of State's Oregon Administrative Rules Database, and ODE's Division 22 Standards Newsletter. Asst. Supt. Knee also outlined Division 22 Waivers for 2023-24 as well as new rules in effect for the 2023-24 school year.

Beginning in 2024-25, districts are required to have a planned K-12 instructional program for Social and Emotional Learning, as well as a planned grades 9-12 instructional program which includes the Personal Financial

Education and Higher Education and Career Path Skills content standards. Included in the report were diploma requirements including modified diploma, extended diploma and certificate of attendance. Districts are further required to have a comprehensive plan for substance use, prevention and intervention.

Board Chair Andrea Miner reminded the Board that this is a report only, requiring no action on the part of the Board. The report will be made available on the district's website prior to the November 1 deadline.

RESOLUTION 24-25-9: DESIGNATION OF AMERICAN EDUCATION WEEK: November 18-22, 2024

Chair Andrea Miner was honored to formally present Resolution 24-25-9: Designation of American Education Week, to be recognized the week of November 18-22, 2024. The resolution proclaims that:

Public schools are the backbone of our democracy, providing young people with the tools they need to maintain our nation's precious values of freedom, civility and equality; and

By equipping young Americans with both practical skills and broader intellectual abilities,

schools give them hope for, and access to, a productive future; and

Education employees, be they custodians or teachers, bus drivers or librarians- work tirelessly

to serve our children and communities with care and professionalism; and

Schools are community linchpins, bringing together adults and children, educators

and volunteers, business leaders and elected officials in a common enterprise.

Director Steve Hammerson moved to approve Resolution 24-25-9: Designation of American Education Week: November 18-22, 2024. Director Ann Krimetz seconded, and the Motion passed unanimously.

COMMITTEE REPORTS

Curriculum and Instruction – September 25, 2024

Committee Chair Ann Krimetz reported that the C & I Committee met to discuss goals for Teaching and Learning and curriculum. While we have a focus on Math, students should be reading and writing every day in every classroom. This is something we are strongly emphasizing this year. Teaching and Learning will be conducting ongoing assessments, adjusting and making improvements as needed. We are focusing time and energy on our schools and with teacher leaders with support from professional development. Director Krimetz added that we will be adopting new K-5 literature curriculum with the goal that students will be able to develop a love of reading to help them become proficient. One of the positive things happening to encourage a love of reading was the recent "Reading Under the Lights" event at Legion Field. Student athletes from the high school and UCC supported the event by engaging in activities with the children.

A health curriculum sub-committee will be involved with evaluating Grades 6-12 health curriculum. Families will have access to review lessons and have the option to opt their child out of a lesson if they desire.

Student Services – October 2, 2024

Committee Chair Andrea Miner shared that the committee met October 2nd for a mandatory review of Restraint and Seclusion data for the 2023-24 school year, along with special program classrooms. Oregon law requires districts to track yearly restraint and seclusion data and make it available to the public. Our district experienced a significant decrease in situations that required the use of restraint last year; the district does not practice seclusion. Staff are receiving Crisis Prevention Institute (CPI) training several times per year, and this has resulted in reducing restraint occurrences from 144 to 19. Student Services is currently reviewing all special programs. The number of students on Individualized Education Plans (IEPs) stands at 780. This does not include students whose primary need is speech and language related. Unfortunately, funding from the Oregon Department of Education does not currently cover the costs of the district's percentage of students on IEPs.

DISTRICT DIRECTOR REPORT (Effective Operations: Purchasing Services)

We will align district resources and establish data-informed systems to support exceptional learning environments

Purchasing Supervisor, Denny Austin, began his report by sharing that since the beginning of this year, we have saved \$20,000 by utilizing surplus items instead of having to go out and buy new items. He explained that a "Buy Decision" can be reached through any of the following:

- Surplus
- QRF
- OCE
 - Inmate created furniture or large pieces of welded equipment
- State Price Agreement
 - State goes out to bid through the Dept. of Administrative Services
- IGA
- Open Market
 - Cooperatives
 - Bids and Proposals

Cooperative Purchasing include:

- Gratis
 - ORCPP
 - OETC
 - o Omnia Partners, etc.
- Subscription
 - Amazon (organizations must subscribe to Amazon Business Prime)
 - o KCDA
 - Used for large purchases such as building modulars, lighting, flooring, etc.

Mr. Austin further explained that the district's purchasing policies are much stricter than those of the State. The district utilizes formal procurement for items exceeding \$50,000. Our goal is to encourage competition.

Open Market Sourcing includes:

- RFI / RFQ
- Small

- \$5,000 or less pre-approved purchases; market research and quotes are advised
- Intermediate (between \$5,000 and \$50,000); attempt to secure three quotes using clear specifications
- Sole-source
 - Verify it's a sole vendor provided product; publish seven-day protest period

 - o Requires a declaration from the Superintendent; encourage competition
- Special

Denny provided data on savings achieved during the 2023-24 school year. The district is also able to provide outside sales to neighboring districts, with resulting income of \$11,246 from that last year.

SUPERINTENDENT REPORT (slide deck follows)

Superintendent Cordon reflected on the care, support and instruction provided at RPS, giving a shout out to RHS teacher, Sheri Carson, one of Oregon's Regional Teachers of the Year! Students at Joseph Lane Middle School created anti-bullying videos for their peers. Roseburg FFA students helped at the 2nd annual Douglas County Farm Bureau's Ag Explorer Day for 4th graders around Douglas County, and five of our schools participated in "Reading Under the Lights" at Legion Field.

We are proud that RPS students are above state average in many areas, while in some areas we have trended down. At RPS we have high expectations around student achievement, and will always be looking at best ways to support teachers, instructional staff and families for the betterment of our students. The end of Oregon's 2023-2025 biennial budget cycle is approaching. School districts are dealing with an onslaught of legislated unfunded mandates that cost significant dollars. In our district, grants and funding sources are being reviewed through the lens of whether the programs & expenditures are moving our Strategic Plan forward. He shared W.E. Deming's quote, *"A bad system will beat a good person every time."*

Jared thanked the board for leaning into the work of examining the facilities needs of our district as we move toward updating our Long-Range Facilities Plan, a requirement for any district to apply for and receive future OSCIM grant funding. Last, during the month of October, we hope you will join us in celebrating all Roseburg Public Schools principals during National Principals Month!

BOARD OF EDUCATION REPORTS

Director Keith Cubic wanted to share three items. One of his neighbors who received a new fence alongside Fullerton IV Elementary discovered it was above ground level elevation and cause for concern. The district was able to remedy the issue and the patron and Mr. Cubic wanted to convey their thanks to both the district and the Facilities staff. Mr. Cubic also shared an actual leaf with a rendering of a smiley face given to him by one of the maintenance crew at Fullerton, Jim, while he was mowing the area. Jim shared that when he encounters children during the course of his duties, he often presents them with one of the leaves, which makes them very happy. Last, Director Cubic reported that in his conversations with families, they are happy with school this year and were very complimentary of their child's teachers.

Chair Andrea Miner reported that both she and Vice-Chair Rodney Cotton were invited into RHS teacher Mary Malopsy's classroom to interact with students interested in the field of education. Both she and Rod were honored to have the opportunity to respond to questions about school funding and regulations. The students' vision for their educational journey and individual pathways they were pursuing were impressive. One student was in the CTE program, and another was considering law enforcement and EMT. He shared that his interest drives his hope to serve and learn more about children and how best to serve them. Chair Miner was very pleased to report that these fine students are "A-1" and these are our kids!

ADJOURNMENT: With regular business before the Board concluded, and with no objections, Chair Andrea Miner adjourned the meeting at 7:19 p.m. and announced that the next meeting will take place at the central office on October 23rd at 6:00 p.m.
