School, Parent, and Family Engagement Policy

PART I. GENERAL EXPECTATIONS

Rosenthal Montessori agrees to implement the following statutory requirements:

- 7. Rosenthal Montessori will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not certified in the area which he/she teaches by:
 - a. Right to Know Letters
 - b. Orientation Meetings
 - c. Parent/Teacher Conferences
- 8. Rosenthal Montessori will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below:
 - a. the state's academic content standards.
 - b. the state's student academic achievement standards,
 - c. the state and local academic assessments including alternate assessments,
 - d. the requirements of Part A,
 - e. how to monitor their child's progress, and
 - f. how to work with educators:
