Testing Information

Dates and deadlines have been set for the 2023-24 Cognitive Abilities Test (CogAT7). This test determines student eligibility for accelerated services in Saint Paul Public Schools.

The CogAT7 test will be provided to all SPPS students in kindergarten and in second grade between October 7 -November 7.

Students in grades 1, 3, 4 and 5 may also be nominated for this assessment by an SPPS staff member, family member or community member.

Please email stacy.klage@spps.org if you would like to nominate a student as soon as possible. The deadline for student nominations is October 18th.

If you would prefer that your student not participate in the CogAT7 testing, please provide a written note indicating that choice to Principal Moeller.



School Attendance Matters

On Time. Every Day. Every Class.

It is important for students to be in school the entire time that school is in session.

All students should be in their classroom from 7:30 am until their teacher dismisses them at the end of the day at 2:00 pm.

Tardy students and students that are picked up early are distracting to the entire classroom.

Students leaving early may miss last minute instructions given by the teacher.

To avoid being referred to the School Attendance Matters Program do not pick up your child(ren) early from school unless:

*they are ill

*they have a medical/dental appointment

*there is an extreme family emergency

Parents/guardians <u>MUST</u> communicate <u>every time</u> a child is absent. Please note not all absences will be excused.

Call in or send a note to the main office, state reason for absence. Be specific.

Documentation may be required to excuse these absences.

Parents please remember that if your child has had a fever (over 100.4 degrees), diarrhea or vomiting;

of symptoms free and NO medicines given before you send your child back to school.


