

## DRUG AWARENESS AND SUBSTANCE ABUSE


#### Percentage of Past Year Substance Use Among Texas Student in Grades 7-12: 2020

#### What is Fentanyl?

- Synthetic opioid
- About 50x stronger than heroin
- Used in a clinical setting since the 1960s (surgery and pain management)
- Illegally manufactured fentanyl is a powder
- Can be used alone or combined with other drugs



#### Reverse Opioid Overdose with Naloxone

#### Naloxone a.k.a NARCAN

- No psychoactive properties or harmful effects
- Can be administered by anyone
- Only works if opioids are in a person's system does not work for alcohol poisoning or other drugs
- Effects wear off in 20 -90 minutes
  - Stay with the person until help arrives or at least 4 hours to make sure their breathing stays normal



### What is GISD doing to help educate parents on substance abuse?

#### **Parent Presentation**

Dr. Jessica Cance oversees the analysis and dissemination of health information available at the Texas Department of State Health Services and other Texas agencies. Immediately prior to her current position, she served as the Interim Prevention Lead for the Texas Targeted Opioid Response project at the Texas Health and Human Services Commission (HHSC). Jessica joined HHSC after working six years as an assistant professor at the University of Texas at Austin.

Dr. Cance has nearly 20 years of experience working in adolescent and young adult health promotion, including epidemiological research, program implementation, coalition building, and national evaluation projects.
