

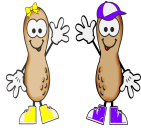

## 2024 - 2025 Parent Engagement Policy

What is it?	Parents, students, teachers, and school staff share the responsibility for improved student academic achievement. Carver Early Education Center will build and develop a partnership, a high-quality curriculum, instruction, and a supportive and effective learning environment to help the children meet the State's academic achievement standards.
Funding	Title I funds will be allocated for the implementation of the parent and family engagement program. Such programs, activities, and procedures will be planned and implemented with meaningful consultation with parents of participating children
Review	All use of funding and activities can be reviewed by the Texas Education Agency upon request to ensure they meet the need of the PFE Program.
Communication of Policy	Carver Early Education will involve parents in an organized, ongoing, and timely way in the planning, review, and improvement of programs offered through Title I. This policy will be distributed to parents, in English and Spanish, at the beginning of the year and during the Annual Title I meeting. In addition, this policy will be posted on Carver's webpage in English and Spanish. This policy will be revised during the annual evaluation held at the end of the school year. Parents will jointly conduct an evaluation of the content and effectiveness of the parent engagement policy and revise as necessary. Parents will receive the annual evaluation survey in the Spring. Parents will have the opportunity to review the parent engagement policy and the school parent compact and submit their recommendations.
Family Meetings	Annually, two meetings will be held at a convenient time, to which all parents will be invited and encouraged to attend, to inform parents of the school's participation in the Title I program, explain the requirements of Title I program, and the right of parents to be involved. These meetings will be held in the Fall. Parents will be notified via email and notes sent home with students, in English and Spanish. During these meetings, parents will receive a copy of the parent engagement policy and the school parent compact, in English and Spanish.
How to be involved	Parents will be provided with opportunities for regular meetings to formulate suggestions, share experiences with other parents, and to participate in decisions relating to the education of their children. The school will offer a flexible number of meetings, such as morning and evening. Academic Parent Teacher Team meetings will be held in the Fall and Spring semesters.
Family Trainings/Activities	Parents will be provided timely information about programs through SEESAW Messages, FaceBook, , and notes sent home.
Curriculum	Frog Street Press is the chosen ECISD curriculum for PreK students.
Forms of Academic Assessment	Forms of academic assessment used to measure student progress include: Circle (CLI) Testing, Istation, and classroom assessments. Teachers will communicate student progress throughout the year.
