Executive Summary

- ❖ The following narrative of all funds is in accordance with AB1200 and AB2756, which requires projections for the budget year and the two subsequent years. The two major criteria required for all three fiscal years:
 - Positive cash flow
 - Positive fund balances
- ❖ The Budget is assigned one of the following certifications:
 - Positive certification: when the district meets its financial obligations for the current and two subsequent fiscal years.
 - Qualified certification: when the district may not meet its financial obligations for the current or two subsequent fiscal years.
 - Negative certification: when a district is unable to meet its financial obligations for the remainder of the current year or for the two subsequent fiscal years.

Economic Overview

- ❖ U.S. economic growth has slowed and is expected to decline further in 2024.
- ❖ Economic growth has slowed recently, with the first quarter of U.S. GDP below forecast at 1.6% - the slowest pace of growth since 2022.
- ❖ Restrained growth is predicted to continue, although a short-term recession is no longer projected.
- ❖ California's unemployment rate is currently the highest in the country, at 5.3%, compared with the U.S. rate of 3.9%.
- ❖ The stock market is trending upward overall.

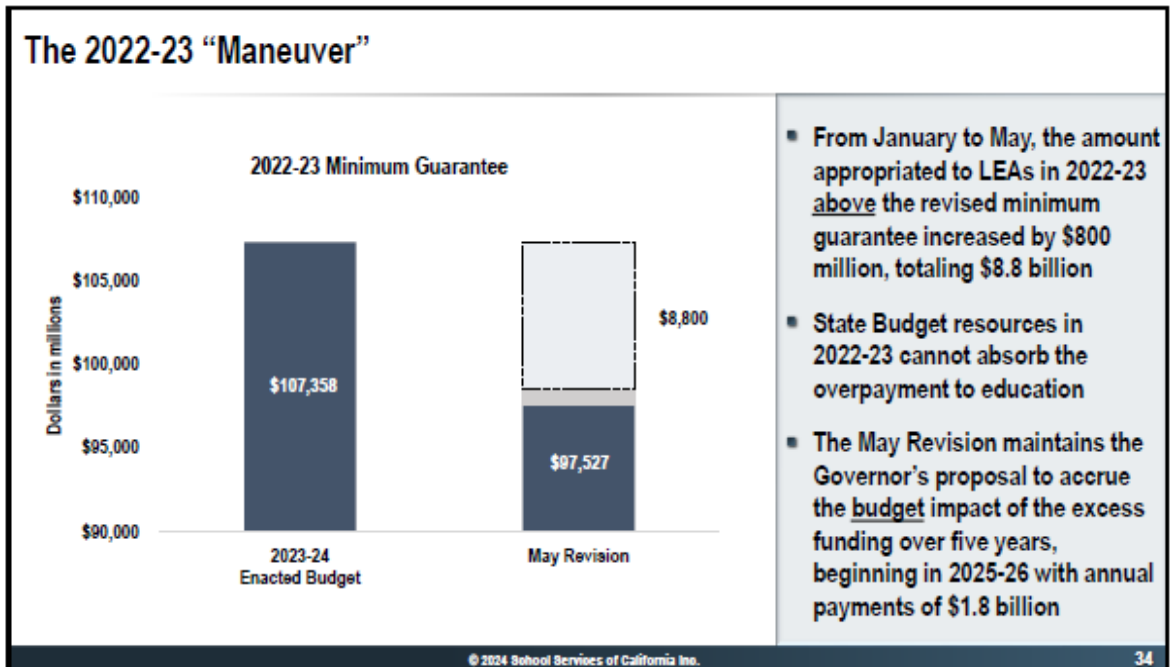
The Budget Problem

- ❖ General Fund revenues spiked in 2021 and 2022; followed by a dramatic decline in 2023 and 2024, combined with delayed tax filings, which drove the major deficits in 2024-25 and 2025-26.
- ❖ The Governor projected a \$37.9 billion budget deficit for 2024-25 in January. Now \$27.6 billion at the May Revision, which shrunk the shortfall by \$17.3 billion.
- ❖ Governor Newsom projected the budget cut outside the education. Big reductions impact other programs such as climate change, housing and homelessness, and some health and human services
- ❖ Fortunately, the Governor proposed to protect ongoing K-14 education and provide a 1.07% COLA for 2024-25.
- ❖ This is accomplished by fully depleting the Proposition 98 Rainy Day Fund (approximately \$19.4 billion), increasing the size of the Proposition 98 “funding maneuver,” and cutting one-time education funds.

May Revised

The Cause and the Impact of 2022-23 “Maneuver”

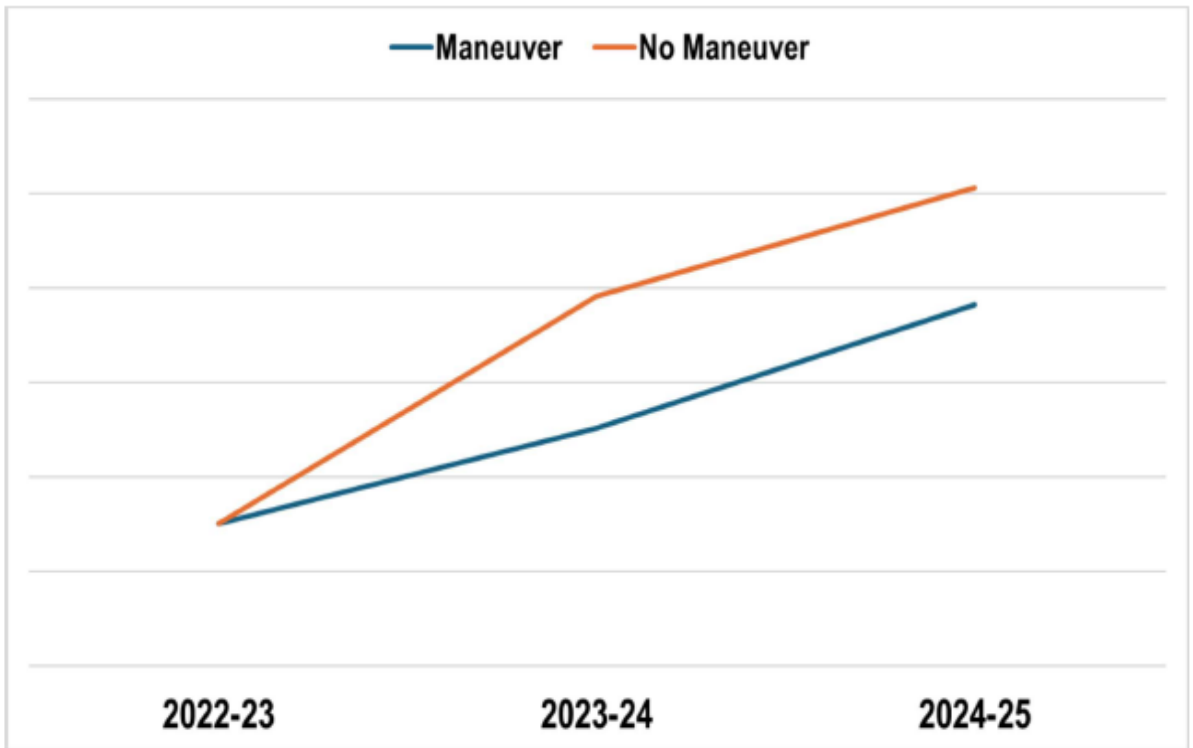
- ❖ The Governor’s “maneuver” proposed to address the precipitous drop in the calculated 2022-23 minimum guarantee through future “payment” to education from the state General Fund above the constitutional levels in those future years.
- ❖ The maneuver does not credit the \$8.8 billion to the 2022-23 fiscal year.
- ❖ The \$8.8 billion problem stems from the fact that the 2023-24 Enacted Budget was passed months before the state had a clear picture of the amount of revenues it could expect to receive from personal income and corporation taxes for the 2022 tax year
- ❖ The Internal Revenue Service delayed the tax filing deadline from spring to the fall
- ❖ Combined with the aggressive revenue assumptions, laid the ground for the riskiest budget in over a decade



May Revised Proposition 98 Maneuver

The estimated impact on education funding in the current and budget year is approximately \$12–14 billion. That is, the Newsom Administration’s maneuver would reduce Proposition 98 funding by \$12–14 billion across the two years, with significant implications for education funding in the outyears.

If Not the Maneuver, Then What?

If the final budget deal doesn’t include the Governor’s maneuver, he and the Legislature will have to grapple with increased obligated funding for education that is significantly higher than the May Revision levels for 2023–24 and 2024–25. Importantly, the state began running an operating deficit in Proposition 98 two years ago when the cost of education investments began outpacing growth in Proposition 98. The \$8.8 billion problem deepens the deficit.

So, if lawmakers avoid the maneuver, then what options do they have to meet the state’s constitutional obligations to education?

This is the question that legislative budget leaders began asking yesterday, May 16, 2024, at their first hearings to review and evaluate the Governor’s May Revision.



District Budget

- ❖ District Budget Status: Based on the current assumptions and projections, the District balanced its budget with a positive balance for 2024-25 and the next two subsequent years.
- ❖ The District proposes its preliminary budget based on the State May Revised Budget presented by School Service California and the Capitol Advisors Group.
- ❖ MPESD, like other districts in Santa Clara County, is experiencing declining enrollment as families move out of the area due to high housing costs.
- ❖ Challenges that Local Education Associations (LEAs) are facing stay the same as the previous years and financially get worse for the subsequent years:
 - Decrease COLA from 8.22% to 1.07%
 - Declining enrollment is a major concern that has impacted the funding
 - Costs of inflation
 - Recruiting and retaining staff
 - Retirement costs increasing
 - Collective Bargaining compensation cost pressures
 - Expiring one-time and COVID-19 funds
 - Funding spending deadlines and restrictions
 - Plan completion and update

Budget Planning Factors

State COLA vs Local COLA

- ❖ For the budget year, the district projected a 6% declining enrollment
- ❖ The 1.07% COLA in 2024-25 translated into a Local COLA for MPESD equaled a negative 7.35%, which was \$1,705,228 less in the LCFF base grant compared to 2023-24. That did not include other categorical funds, which were also funded based on the student enrollment.
- ❖ Significant COLA declines since the enacted budget time, from 3.94% in July 2023, down to 0%-2% at First Interim, and down to 0.76% in January. Even though the May Revised slightly increased to 1.07%, it is still a decline of more than 50% compared with the beginning of the year.
- ❖ The fluctuation of COLA created tremendous difficulties in developing the budget, especially this huge drop comes right after a year with an all-time high COLA of 8.22%.

Budget Assumptions

- The District borrowed \$1.85 million from Fund 17 to maintain the minimum 3% reserve for the next two subsequent years.
- LCFF Revenue estimated a 6% decline in enrollment for all 3 years
- In 24-25, we projected one FTE Art Teacher and one FTE Music teacher using the Prop-28 Art & Music fund. The term for these two positions will be ended when the fund is no longer available to the district
- Step and Column Adjustments increased by 1.5% in the next two subsequent years
- Projected budget reductions in Multi years due to decline in enrollment, reducing COLA, and most of the one-time restricted funds have been fully spent in 2023-24

In 2025-26

- Estimated 6% in decline enrollment for LCFF Revenue
- Reduced 10% salary and benefits costs in unrestricted funds
- Reduced 10% Book & Supplies, and 10% Services and Operation Cost in unrestricted funds

In 2026-27

- Estimated 6% declined enrollment for LCFF Revenue
- Reduced 6% salary and benefit costs in unrestricted funds.
- Reduced 6% Supplies and Services costs in unrestricted funds

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates

the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.

Where the ratio of indirect costs incurred in the current year is less than the estimated ratio of indirect costs on which the approved rate for use in the current year was based, the carry-forward adjustment is limited by using either the approved rate times current year base costs, or the highest rate actually used to recover costs from any program times current year base costs, if the highest rate used was less than the approved rate. Rates used to recover costs from programs are displayed in Exhibit A.
