Public Content

WHEREAS, The Board of Education of the White Plains City School District on April 26, 2024, publicly advertised and invited sealed proposals for Independent Investigation Services for the 2024-2025 school year. The proposals were required to be received by July 1, 2024:

AND WHEREAS, proposals were evaluated on a weighted system established by the district for each of the categories to be reviewed. The evaluation criteria included special knowledge or expertise of the proposer, suitability for the district's needs, proposer credentials and certifications, quality of services to be provided, staffing/time available and fee schedule as reasonably determined by the district.

AND WHEREAS, in July, the White Plains City School District conducted eight screening interviews with firms to access their background, expertise and track record in carrying out these investigations. The goal with these screenings was to establish a bench of investigators that the district could choose from depending on the nature of the employee investigations needed;

AND WHEREAS, Dizon & Shedden, P.C., Berry Consulting Services, LLC., and TrueView BSI, LLC., submitted proposals for the services and at the rates attached;

THEREFORE, BE IT RESOLVED, that based on the evaluation criteria established by the District, the Board of Education accepts the proposals and authorizes the Assistant Superintendent for Business to enter into agreements with Dizon & Shedden, P.C., Berry Consulting Services, LLC., and TrueView BSI, LLC. to provide Independent Investigation Services for a contract term of July 1, 2024 - June 30, 2025.
