





#### **GROWTH**



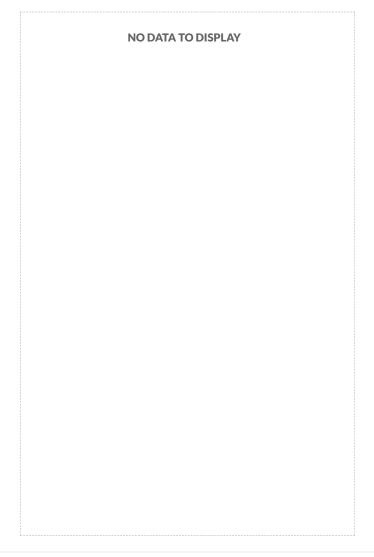








