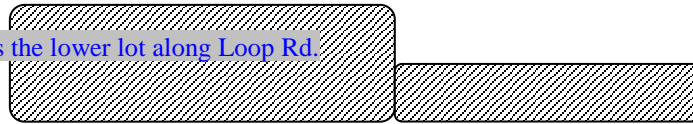

CAREER MAGNET SCHOOL DRIVING REGULATIONS

Parking motor vehicles on school property is a privilege granted by the school district to students who use good judgment in the use of their vehicle and comply with school district policies. Parking is strictly for student currently attending CMS. Students who fail to comply with the driving regulations may lose parking privileges. Vehicles parked on school property may be subjected to search for unauthorized materials. These unauthorized materials may be used as evidence against you in disciplinary, juvenile, or criminal proceedings. The school district will assume no responsibility for loss due to theft or damage to vehicle and for student drivers transporting passengers.

1. All rules and regulations as listed in the student handbook apply to the student parking lot.
2. Students must wait inside of the school until all school busses have loaded and have departed the area.
3. Students may not loiter in or around cars. Once students arrive they must go immediately into the school. They are not permitted to leave the school campus.
4. All students must display parking permit at all times on their rearview mirror.
5. Students must park in the assigned numbered space. Students are not permitted to park in the staff lot.

The student parking lot is the lower lot along Loop Rd



6. Violation of parking rules and regulations may result in any or all of the following:
 - a. citation
 - b. disciplinary action
 - c. loss of parking privileges and parking fee
7. The principal may revoke parking permits for 20 school days OR longer if students are cutting classes and leaving school property.
8. Financial and/or detention obligations must be met before students are eligible to purchase a parking permit.
9. **Dismissal for drivers & riders is 2:40pm.**

The parent is liable for the student who does not accept school furnished transportation. All students riding in the automobile also become the responsibility of the parent of the driver. I understand that violation of parking regulations may result in losing driving privileges and forfeiting parking fee. This form must be signed and returned to the high school office. I hereby give my permission to my son/daughter to drive to school I further accept the liability for my son/daughter when he/she drives.
