Purpose and Requirements for DELAC

A district-level English Learner Advisory Committee comprised of parents, staff, and community members designated to advise district officials on English learner programs and services.

California Education Code (state law) states that each California public school with 51 or more English Learners shall form a District English Learners Advisory Committee (DELAC).

The purpose of the DELAC is to provide guidance and advice to the Governing Board and District staff on the needs of English language learners and services.

Propósito y Requisitos para DELAC

Un Comité Asesor de Estudiantes Aprendices de Inglés a nivel de distrito compuesto por padres, personal y miembros de la comunidad designados para asesorar a los funcionarios del distrito sobre los programas y servicios para estudiantes aprendices de inglés.

El Código de Educación de California (ley estatal) indica que, cada escuela pública de California con 51 o más Aprendices del Inglés deben formar un Comité Asesor de Aprendices del Inglés del Distrito (DELAC).

El propósito del DELAC es proveer orientación y recomendaciones a la Mesa de Miembros Directiva y al personal del Distrito sobre las necesidades y servicios para los estudiantes Aprendices de Inglés.

The committee should advise on the following tasks:

- ❑ In the development of a district plan to ensure compliance with requirements and authorizations for teachers and instructional assistants working with identified English Learners. (EL Master Plan)
- ❑ To review and comment on the district's procedure for the reclassification of identified English Learners.



El comité debe de aconsejar en las siguientes tareas:

The committee should advise on the following tasks:

- ❑ To review and comment on the written notices required to be sent to parents or guardians.
- ❑ To review attendance trends and engage in discussions to promote an increase to student daily attendance.
- ❑ To engage in a district-wide needs assessment plan based on identified EL needs.

DELAC Membership

- ❑ Parents of EL students must make up a majority of the committee(51 percent or more).
- ❑ DELAC members are elected by School Site Councils/English Learner
- ❑ Advisory Committees at each school site.
- ❑ Each school site elects one DELAC member.
- ❑ Members must be the parent/guardian of a student who is an English learner who attends school in the district
- ❑ DELAC parents may remain on the committee if their child is reclassified during the school year
- ❑ Parent members may not work for the district or school site



Composición del DELAC

- ❑ Los padres de alumnos EL deben constituir la mayoría del comité (51% o más).
- ❑ Los miembros del DELAC son elegidos por los Consejos Escolares/Comités Asesores de Aprendices de Inglés de cada escuela.
- ❑ Cada escuela elige a un miembro para DELAC.
- ❑ Los miembros deben ser padres/tutores de un alumno que esté aprendiendo inglés y que asiste a la escuela en el distrito.
- ❑ Los padres de DELAC pueden permanecer en el comité si su hijo es reclasificado durante el año escolar
- ❑ Los padres miembros no pueden trabajar para el distrito o la escuela.

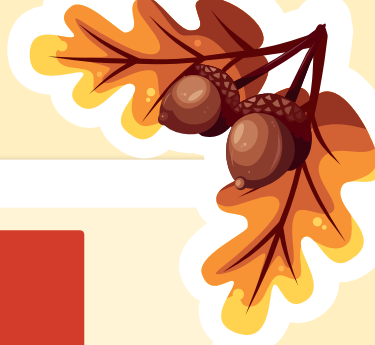

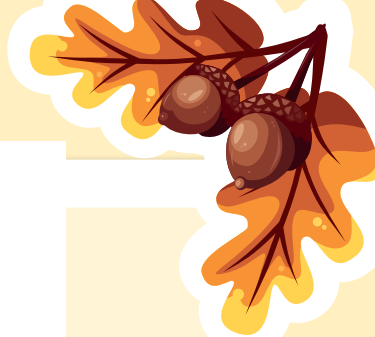

Initial English Language Proficiency Assessments for California (ELPAC) 2022-2023

Dear Parent/Guardian,

State and federal laws require schools to identify English learner (EL) students in need of language assistance services. In California public schools, all students entering school for the first time will be assessed with the Initial English Language Proficiency Assessments for California, or "Initial ELPAC," if their home language is not English. You indicated that your child's primary or home language is not English when registering your child for school.

The Initial ELPAC is the test used to determine if a student is an English learner or is fluent in English and whether students are eligible for language assistance services. Students are tested on their skills in listening, speaking, reading, and writing. Your child's voice is being recorded as part of the Speaking test. A small percentage of student responses may be used to validate the accuracy of scoring and will not be used for identification. All recorded responses will be destroyed after the scores are validated.

This required test will help identify students who need help learning English. This is important so they can get the support they need to do well in all school subjects. Based on the home language survey results, **your child will be assessed with the Initial ELPAC.**

You are an important part of your child's education. To help your child get ready for the test, you can:

- Read to your child, or have them read to you on a regular basis.
- Use pictures and ask your child to tell you what they see, or what is happening in each picture.
- Provide your child with opportunities to use language outside of school.
- Talk with your child's teacher about your child's listening, speaking, reading, and writing skills to help support their progress.
