## William Mendenhall Middle School School Plan for Student Achievement 2024 – 2025 Executive Summary

#### Overview of School Demographics (24-25)

- Students
- 53.9% White
- 25.3% Asian
- 18.9% Hispanic
- 1.1% African American
- 13% Socioeconomically Disadvantaged (SED)
- 2.3% English Learner (EL)
- 10.7% Students with Disabilities (SWD)



#### 2024 – 2025 Data Trends (Highlights)

- Mendenhall Middle School earned a Positive Behavioral Interventions and Supports (PBIS) Gold award
- Mendenhall Middle School earned the Schools to Watch award
- California Assessment of Student Performance and Progress (CAASPP) Mathematics proficiency improved by 4% from 55% to 59%.
- California Assessment of Student Performance and Progress English Language Arts (ELA) proficiency improved by 1% from 69% to 70%.

#### 2024–2025 Data Analysis and Conclusions

- The data indicates both positive and negative trends in academic proficiency, student-teacher relationships, English Learner progression, and student behavior.
- English and Math teams will review learning strategies and assessment data to improve instruction.
- Continue to work with our Instructional Leadership Team to improve data collection, and communicate student assessment results with teachers, parents and students
- Review both ELA and Algebra assessments to improve data collection.

#### 2024-2025 LCAP Site Goals

- Increase the percentage of students proficient in ELA overall CAASPP Scores in 2024-2025 to 73%.
- Increase the percentage of students proficient in Mathematics in 2024-2025 to 59%.
- Continue weekly articulation to students, parents and staff through regular face to face meetings, electronic communication and updated website.
- Decrease the number of students suspended to 1.4% of students in 2024-2025.
- Improve the average attendance rate for 2024-2025 to 97% or more.
- Increase the percentage of English Learners progressing at least one ELPAC level to 55%.
- Increase the frequency of positive parent and student communication with school.
