Candidate Eligibility Requirements <i>Requisitos de Elegibilidad del Candidato</i>	Deadline to File Candidate Application <i>Fecha Límite Para Presentar la Solicitud de Candidato</i>
To be eligible to be a candidate for, or elected or appointed to, the office of school board member, a person must: <ul style="list-style-type: none"> • Be a United States citizen. • Be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable. • Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote. • Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities [but see Ineligibility below]. • Have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date: 	February 14, 2025 (5:00 PM)

- a. For an independent candidate, the date of the regular filing deadline for a candidate's application for a place on the ballot.
- b. For a write-in candidate, the date of the election at which the candidate's name is written in.
- c. For an appointee to an office, the date the appointment is made.
- Be registered to vote in the territory from which the office is elected on the date described at item 5, above.

Election Code 1.020, 141.001(a); Gov't Code 601.009; Tex. Const. Art. XVI, Sec. 14

A person may not be elected trustee of an independent school district unless the person is a qualified voter. *Education Code 11.061(b)*

A person is ineligible to serve as a member of the board of a district if the person has been convicted of a felony or an offense under Penal Code 43.021 (solicitation of prostitution). *Education Code 11.066*
