

DAC Meeting 9/30/2024

Zoom Meeting

Jim reviewed the Agenda for today's organizational meeting. The DAC meetings will be held on Zoom. The LCAP advisory committee meetings will be held in person at the Family & Community Resource Center. Nominations for the DAC and LCAP Advisory Committees will be accepted soon, anyone interested in either committee can nominate themselves.

Jim went on to explain the purpose of the DAC meeting, it is for Federal Funds, Title I Title II, and Title III. We will review and help understand what the funds are used for. The composition of the DAC is by a member that each site selects at the SSC meeting to be part of this. The committee is made up of parents and staff, with parents being the majority.

Any questions? No one had questions.

The LCAP meetings have the same purpose as the DAC meetings but will go more in-depth on the Local Control Accountability Plan. We will learn about other parent groups and student groups, and how everybody has input on our LCAP. This year we will need a Student Advisory Committee, each HS will have to put together a group. We will be looking closely at the 130-page document that tells the plan on how we plan on spending funds that are allocated and distributed strictly for what we call unduplicated students which are students that qualify for low-income (foster, EL, free/reduced lunch). We will also review the goals we have for each area and how these are tied to the strategic plan.

The DAC meetings will be held on Zoom, the LCAP meetings will be held in person at the Family & Community Resource Center. There will be three DAC meetings and five LCAP meetings in person this school year. The DAC meetings will take anywhere from 30-45 minutes while the LCAP meetings will take closer to an hour.

Jim asked if anyone had any questions about either committee. We would like you all to sign up for one of the committees.

Question: Is this presentation going to be available later, it is too small. I don't know if it is my phone.

Yes, Rocio will upload it on the website and she can email everyone a link to it tomorrow.

Jim shared the link to the Google form where anyone can sign up to be on either committee.

Question: So you want different people for each of the two committees?

If you want to be on both, that's okay. You can share the link with any other parents, anyone can sign up for one or both committees.

The attendees said that Zoom is better and more convenient. Someone did say that doing it in person allows them to network. Jim said the LCAP piece is hard to do through Zoom so those meetings will be held in person.
