#### MINUTES

## October 5, 2009

The Montgomery County Board of Education convened in regular monthly meeting on Monday, October 5, 2009, at 6:30 p.m. with board members present as follows:

Chairman DeBerry called the meeting to order and called for a motion to adopt the meeting agenda. Upon a motion by Mrs. Long, and a second by Mr. Spivey, the agenda was adopted with unanimous approval from the board.

The opening devotional thoughts by Chairman DeBerry were from Ephesians Chapter 15; Verse 16. Be very careful how you live, make the most of every opportunity. Sparky was shy and introverted. Two board visit dates to schools have been changed. Candor Elementary from Oct. 22<sup>nd</sup> to Oct. 21<sup>st</sup> and Troy Elementary from Nov. 16<sup>th</sup> to Nov. 9th.

Dr. Donna Peters introduced Charles DelForge, Principal of Mt. Gilead Elementary School. Mt. Gilead has received the USDA Fresh Fruits and Vegetables Grant. A school focus is making good nutrition fun. Students are made aware of what they are eating and introducing them to other fruits and vegetables. Students were asked to write about their favorite family meal. Parents are also involved in sharing with their children and have come out and shared meals with their children at school. Students shared their stories with the board.

Dr. Peters then introduced Heather Wallace, Director of Communities in Schools. Communities in Schools has been a non- profit organization since 2007. It is operational under CIS National.

Communities in Schools reaches over 500 students, with 250 partners and donors, 200 volunteers, with 600 parents engaged. There are CIS programs in all of Montgomery County Schools except Montgomery Learning Academy this year. A site coordinator at each school is the long term goal. Our focus is to prepare every child for graduation and life after graduation. Two Communities in Schools Board Members, James Spivey and Jim Matheny were also present. Mr. Matheny had written a funded grant. Grants are the continuing lifeblood of this organization. Other resources are always being looked for.

Frank Fiorella announced that National School Lunch Week is Oct. 12-16, 2009. There are several activities planned to involve students, such as choosing your All-Star School Lunch Team, coloring contests, with prizes and certificates.

Kathy Johnston presented the 2009-2010 Budget Resolution. With a motion from Mr. Spivey, along with a second from Mr. Blake, the board unanimously approved the resolution as presented.

- b. She may transfer amounts not to exceed \$50,000 between functions of the same fund with a report on such transfers being required at the next meeting of the board of education.
- c. She may not transfer any amounts between funds.

Section 13 - Copies of the Budget Resolution shall be immediately furnished to the superintendent and school finance officer for direction in carrying out their duties.
