MINUTES

December 7, 2009

The Montgomery County Board of Education convened in regular monthly meeting on Monday, December 7, 2009, at 6:30 p.m. with board members present as follows:

Steven W. DeBerry, Chair James M. Spivey, Vice Chair Almetta Armstrong Tommy A. Blake Ann S. Long Frances H. Reaves Shirley M. Threadgill

Chairman DeBerry called the meeting to order and called for a motion to adopt the meeting agenda. Upon a motion by Mr. Spivey and a second by Mrs. Long, the agenda was adopted with unanimous approval from the board.

The opening devotional thoughts by Chairman DeBerry were from the book of Luke. Our minds are slanted towards the peace and good will of the Christmas season. Sue Hatley introduced Vivacious Crews, Principal of East Middle School. EMS's teacher, April Hurley and media specialist, Linda Renaldi have doubled up on reading. Reading is studied during language arts. Everything depends on reading skills. This skill will make more students ready for advanced learning. Students are excited, motivated, and engaged. There are book clubs, and classroom libraries with 3500 books having been added this year. "Readers today, Leaders tomorrow" is EMS motto for reading.

Sue Hatley then introduced Erie Greene, Ed Caldwell, Lindsay Whitley, and Rochelle Bostic who gave an update on Closing the Gap. Closing the Gap is achieved in many ways such as groups such as Young Men on the Rise, Communities in Schools, graduation coaches, high school academic support teams, data meetings, sharing meetings online, future ready curriculum and college bound curriculum. Having district and school plans-working to get feedback and be measurable. Teachers with no gap were interviewed and asked what they were doing to attain successful results. When families are involved it's a win- win situation. There are Kitchen Table Conversations and Evening Chat meetings which bring a whole group of people from the community together. The meetings can go where the families are, including churches and community centers.

We have partnered with Cleveland County in learning from their successful Closing the Gap efforts. The goals of this core group are: Educate the Community, Leadership Development, Engage Citizens, Quantitative Process within and between communities, Goal Setting and Benchmarks. Students of Young Men on the Rise shared the improvements to their lives since being a part of this group.

Sue Hatley introduced a grant for board approval which will help new teen mother or pregnant teens to continue their education. With a motion from Mr. Spivey, along with a second from Ms. Armstrong, the board unanimously approved their support.

Donna Peters presented information about the Federal Grant, Race To the Top which will provide \$200 Million Federal dollars to be used in local areas. In these economic times we need all the help we can. It represents the federal agenda for schools with high expectations and accountability. Each Board Chair and Superintendent must sign for this grant.
