MINUTES

August 1, 2011

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, August 1, 2011, at 6:30 p.m. Board members were present as follows:

Board members, Steven W. DeBerry and Jesse Hill were not in attendance. The meeting was led by Vice Chairman, Tommy Blake.

Vice Chairman Blake called the meeting to order and asked for a motion to approve the agenda as presented. With a motion from Ann Long, and a second from Sandra Miller, the agenda was adopted with unanimous approval from the board.

Section 10 - The following revenues are estimated to be available to the Special Grant Fund for the fiscal year beginning July 1, 2011, and ending June 30, 2012:

Special Grant Fund 194,734 Local Fund 16,500 Section 11 - All appropriations shall be paid first from revenue restricted as to use, and second from general unrestricted revenues.

Section 12 - The superintendent is hereby authorized to transfer appropriations within a fund under the conditions as follows:

- a. Amounts may be transferred not to exceed 10% between sub-functions of the same fund with a monthly summary of such transfers reported to the board of education at its next regular meeting and entered in the board minutes.
- Amounts may be transferred between sub-functions and objects of expenditures
 within a function without limitations and without a report to the board of education
 being required.
- c. Amounts may not be transferred between funds nor from any contingency appropriation within a fund without board of education and board of county commission approval.
- d. Amounts may be transferred in state or federal projects upon prior approval of the appropriate funding agency. If such transfers require board of education approval under other provisions of this resolution, a monthly summary of such transfers must be reported to the board of education at its next regular meeting.
- e. Amounts may not be transferred which would result in the elimination of currently staffed positions and/or existing programs without board of education approval. NOTE: This condition does not preclude any budgetary decisions and/or recommendations not intended to alter the current educational offerings or levels of supporting service(s), such as, but not limited to site-based conversions of positions (i.e. converting teaching positions to/from teacher assistant positions); and/or restricting, downsizing or reallocating vacant positions.
- f. For the purpose of year-end closeout only, the board of education agrees to suspend the restrictions/provisions of this resolution given that summary of all such transfers must be reported no later than October 2011. And any such

transfers resulting from extraordinary/unusual occurrences/circumstances must be notated and explained.

Section 13 - Copies of the Budget Resolution shall be immediately furnished to the superintendent and school finance officer for direction in carrying out their duties.

Adopted this 1st day of August 2011.

The agenda continued to the 2010-2011 State Accountability Testing Report for preliminary ABC and AYP results. ABCs show growth and performance composites on a state level. AYP is federal and examines subgroup data. The testing bar scale had been raised with the AYP tests. This is only preliminary at this point and will be confirmed by the state.

The following schools ABCs showed high growth: East Montgomery High School, West Montgomery High School, Montgomery Learning Academy, Page Street Elementary, Troy Elementary, and Star Elementary.

The following schools ABCs showed growth: Candor Elementary, East Middle School, West Middle School, Green Ridge Elementary, and Mt. Gilead Elementary.

The following schools met AYP 100%: West Montgomery High School, Montgomery Learning Academy, and Mt. Gilead Elementary.

In the 80% AYP range was: East Montgomery High School - 88.2%, Page Street Elementary - 84%, Troy Elementary - 84%, East Middle School – 82.8%.

In the 60% AYP range was: Star Elementary – 69.2%, Candor Elementary – 64.7%, Green Ridge Elementary – 61.9%, West Middle School – 61.9%.

Communities in Schools, Executive Director, Ashley Sherrill and Board Member, Jimmy Preslar spoke about the status of Communities in Schools. Funding from grants for Communities in Schools ran out in July 2010. This has equated to scaling back staff and raising money through community activities, business donations, and seeking new grants. The goal is to keep going. Through the fund raising so far, 31 children went to camp this summer and there is a summer mentoring program with a different camp each day. The Executive Director, Ashley Sherrill met with each principal to find out what is needed in each school. This way the focus can be on exactly what is needed for each school. Communication with Montgomery County Schools will be forefront, as will be student's needs.

Superintendent Ellis and Kathy Johnson talked about the 10 month pay issue. Effective for school year 2012-2013, there will be no prepayment for employees. This means 10 month employees, teachers, and teacher assistants, first check will be in September instead of August. This is a new North Carolina state law.

Ann Long gave an update from the School Board Association Southern Regional Conference. Mrs. Long brought back a Bible text book that 43 states are using for their Bible History of Religion classes. She thought it would be helpful to see what other states were using. Another work session centered on employee health care on site, this could save time and dollars for the school system through less time lost for doctors appointments and closer

monitoring of chronic health situations. Mrs. Long also brought back information from some construction companies for the time that new schools would be in the plan.

Superintendent Ellis then gave his superintendent's remarks. A major topic has been the budget this year. This is the final discussion until next spring. He has been here almost a year and have been challenged by the budget. We have fought as hard as possible. Now the focus is to provide for student learning. Instructional facilitators have put the emphasis out in the schools. Some positions have not been filled, others have been moved. We have done what can be done to support our teachers while being equitable and fair in all areas. We have seen a lot of growth and there is a lot of potential. We will not use the budget as an excuse. Back to school is right around the corner, ready or not. Back to School/Stay in School Rally is Saturday, August 20, 2011 from 10:00am – 1:00pm. We want as many parents and students as possible. Let's get excited about the beginning of school.

Vice Chairman Blake then asked for a motion to go into closed session for the discussion of personnel. With a motion from Sandra Miller, along with a second from Bryan Dozier, the board unanimously approved the adjournment to closed session.

Upon reconvening, Vice Chairman Blake asked for a motion to accept Superintendent Ellis's Goals and Evaluation as presented. With a motion from Bryan Dozier, along with a second from Shirley Threadgill, they were unanimously accepted. Vice Chairman Blake then asked for a motion to adjourn the meeting, with a motion from Sandra Miller, along with a second from Bryan Dozier, the meeting was duly adjourned.

The next regular meeting will be held on Monday, September 12, 2011.
