MINUTES

March 5, 2012

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, March 5, 2012, at 6:30 p.m. Board members were present as follows:

The agenda continued to the presentation from East Middle School on Project Based Learning. The project teaches students 21st century skills, including organization, time management, and leadership skills. Two portions help to incorporate these things, a historian class which includes scrapbooking Montgomery County which includes researching the history of the area. It has brought an awareness of many things that are special in Montgomery County. The other facet is the poetry café. Students are asked to write and perform their composure. They include word processing, sound, costume, and video of the event. Also included is to video conference with another class in other parts of the country giving and getting feedback.

Phillip Brown gave an update on the Secondary Math Plan. Through feedback from students who have gone to college and found themselves weak in the math area because math, algebra, and geometry have been scheduled early in their high school career, a change is needed. There was a potential gap between sophomore year with math and college as they had the math needed to graduate by sophomore year. An avenue to reduce this inconsistency is to continue to take higher level math classes in junior and senior years. Board policy would have to change to make this a required avenue for graduation, but students are asked to pledge to seek higher levels of math. We have 102 students enrolled in these higher learning math classes. For now this would be a way to overcome this inconsistency.

Deidra Steed gave an update on the AIG plans for students. She went over the priorities of the 2011-2012 program goals. Priority One includes working with schools on delivery of services; development, revision and adoption of new and improved DEP instrument; file auditing and clean up with all AIG students, also getting a updated DEP with clear measurable goals. Priority Two includes a clearly communicated and rigorous process for AIG identification and

completion of required paperwork with an annual review process; development and deployment of an AIG Advisory Committee to make recommendations for program improvements; and a clearly defined training plan for differentiation with teachers. AIG goals and program will be discussed at parent conferences.

Superintendent Ellis gave an update on PDSA. Teachers will be offered resource training before the beginning of school. All teachers have a classroom mission statement and students have developed classroom norms. A plan is being implemented in their school improvement teams. Teachers are putting out their plans to the students. Montgomery County Schools is learning centered, not teaching centered. Accountability is forefront to us. Learning targets are shared with students with the students in turn being involved in the learning process. Chart the progress, question the results and look at the data. ACT gives us the weaknesses to be able to improve, moving to action, implementation does bring change.

Superintendent Ellis shared the draft legislation information concerning Pre-K Legislation that will be voted on later in 2012. We are making sure that Montgomery County Schools Pre-K teachers are tested in the areas that are deemed important in that legislation.

Superintendent Ellis then asked for a motion to approve the submission of the QSCB Grant information for school improvements. With a motion from Bryan Dozier, along with a second from Sandra Miller, the board unanimously approved this grant application.

Kevin Lancaster then brought forth a newly recommended Montgomery County Schools 2012-2013 calendar to be approved. There was a question from Montgomery County Board of Education member, Tommy Blake as to why there were no more days for Christmas this year. The answer is it would take days from spring break if that happened with no days built in for snow/bad weather. With a motion from Ann Long, and a second from Sandra Miller, the board unanimously approved this recommendation.

Superintendent Ellis's remarks concern change. One thing that educators have become increasingly conscious of in the practice of the profession is change. Change comes faster and in larger doses in education today than it ever has. One thing is undeniable, change is hard...particularly in a profession that has not changed a lot in previous decades...that's right decades.

"In preparation for my comments tonight, I tried to find some of the best change quotes I could on the internet. I regularly use quotes, as do many educators, as a means of providing clarity on a topic. If anything is important, you can usually find a quote about it. Here is a list of quotes that are particularly relevant."

"Why do you see quotes on certain topics like change? You see it because it is relevant to life for one reason, but also because it is hard. We never see famous quotes from famous

people about making spaghetti. We never see famous quotes about the importance of typing our shoes. Why? Because those things are easy. Change is hard, therefore it is important to speak about it and to inspire people to want to do it. That inspiration has been a focus of mine for the better part of this year. I feel the frustration of staff as we continue to face change locally, and from the state, and nation, so I felt it to be a good topic for my comments tonight."

"When I first met this Board in May of 2010, I told them that if they would give me five years that they would see unprecedented student results in Montgomery County. Why 5 years? Because change is hard and it must be tackled in measured chunks to be effective. We talked about changing processes that would impact student learning and we have been on a journey very successfully to this point."

"We are into our second year of my tenure here and we have fully implemented the PLC process and we are training teachers on the use of high yield instructional strategies based upon the work of Robert Marzano. These strategies are being used in classrooms throughout the system. Our pace of change has been good and we are seeing the results of this hard work by teachers. We are now implementing the PDSA process which will be totally deployed in August at every school. So, by the end of my third year, we will have fully implemented the changes I discussed with the Board in May 2010 and have that other 2 years to perfect the processes and get those unprecedented results I discussed with them at that time. We are right on schedule."

"But, other things have developed outside of our control. In May 2010, no one had ever heard of Race to the Top. There is no talk of a totally new accountability system in the state of North Carolina. Online testing was something just talked about as if it were someone's dream. There was no standard six, which measures student results in the teacher evaluation model and no one had any inkling that students would be surveyed as part of that same teacher's evaluation, a process which will be piloted next year in many districts. No one could even fathom the thought of Pre-K being dismantled, or that the legislature would view the NCAE as an enemy of the state as we currently see. The Common Core curriculum standards were first being mentioned as a possibility and this will now be our standard curriculum in the state, a complete overhaul in just a couple of years. In May 2010 we could not even imagine the scope of the massive changes we have seen in these 2 short years. In short, the game has changed and it continues on."

"I feel the frustration of these changes as does our valuable staff members, particularly our teachers. I'm right there with you. The only thing I can say is to encourage everyone to stay the course. To say that we can totally transform our system to one that achieves student results that are the envy of the state is still within reach. Stick with it over the next few years and you will be glad you did. That five year plan is still in place and progress toward it moves at a steady pace. We are already seeing the results with our students. In reference to competition and the presentation that I made to every staff a couple of months ago, we will be the best alternative in not only our county, but our region. The implications for economic development in our county are tremendous with the results we can achieve. With the continued hard work of our teaching staff and others, we will be laughing at our vision to be in the top 25 in North Carolina. In short order, that will be way too low for us to aim for."
