#### MINUTES

### August 6, 2012

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, August 6, 2012, at 6:30 p.m. Board members were present as follows:

Chairman DeBerry called the meeting to order and asked for a motion to approve the agenda as shown, with the change to approve the consent agenda after the closed session. With a motion from Bryan Dozier, and a second from Sandra Miller, the agenda was adopted with unanimous approval from the board with this change.

Opening remarks by Chairman DeBerry about great leaders such as George Washington. A great leader is always focused on the goal, never refusing to give up.

The Pledge of Allegiance to the Flag of the United States of America was led by Chairman DeBerry.

With no one signing up to address the board the meeting proceeded to the recognitions.

A Resolution of Esteem was made to the family of Maurince Edward "Frenchie" Pion a former Montgomery County Schools employee.

Montgomery County Schools awarded it's Community Partnership Award to Rodney Qualls with Macon Martial Arts. They support many activities at Page Street Elementary School from giving the teachers breakfast as well as give a marshall arts program for the students. Montgomery County Schools thanks you.

Ja'quil Capel a 2012 graduate of West Montgomery High School was honored as the East-West All-Star Football Athlete for 2012.

Phillip Brown gave an update on SAT/ACT PDSA. ACT testing is required for Juniors, so we will see further decrease in SAT%. SAT is an elective, ACT is not. Most North Carolina colleges accept the ACT test. The Department of Public Instruction will give a PSAT before the SAT in Sophomore year to predict strengths and weaknesses to help identify what area is needed to do well on the SAT. Explorer is done in Eighth Grade also with the same predictable means as in Sophomore year. We provide after school preparation programs to prepare for both tests, Montgomery Community College offers classes, we have outside trainers to work on test strategy. We use publicity with students and families, magnets, articles, parent meetings and special events to make them aware of all that is offered for students to help them be successful in their endeavors in this area.

Next, Deidra Steed gave an AIG update. Students are chosen in fourth grade for the AIG programs. They continue AIG throughout high school. It is being looked at as to what criteria must be met to maintain the AIG status. All students do not hold on to their high level of work. After all efforts of helping those students maintain have been exhausted, Mrs. Steed, the teacher and the parents would together decide the best plan for these students. For those that do maintain their AIG status there are STEM/Leadership Classes, JR.ROTC Classes, Math Fairs, Lego Robotics, field trips, and other project based learning where students can come up with a plan or project which could be related but not limited to science, technology, engineering, mathematics. An AIG calendar and information is sent out to parents at the beginning of the year.

Alisha Ellis gave an update on PDSA which stands for Plan, Do, Study, Act. Page Street Elementary piloted this and it will be district wide with training on August 24, 2012. Classroom learning system includes: Classroom Mission Statement, Class norms/ground rules, Clear understanding of essential curriculum, Data from pretests, formative assessments and predictive assessments, and a classroom environment that supports the upcoming year. Curriculum will be posted this year with classroom walk-throughs.

A resolution for further QSCB Funding was asked to be approved by Superintendent Ellis. The process is moving along with the state. With a motion from Bryan Dozier, along with a second from Ann Long, the board unanimously approved the resolution.

One policy code 4317-R School Uniforms was presented to be voted on out of policy in order to be in place for the beginning of school. With a motion from Bryan Dozier, along with a second from Sandra Miller, to suspend the regular policy of 30 days wait, the board unanimously approved the suspension. A motion to approve the policy as presented was made by Tommy Blake, along with a second from Bryan Dozier with the board unanimously approving the policy.

Superintendent Ellis went on to present his remarks. "I am pleased overall with the way things are going in Montgomery County Schools. Data will be shared next week at the board of education retreat, 100% of our schools have met growth standards. Hard work has been done and we are pleased with the results. I hope our teachers have rested, recycled, and reloaded. The board has remained committed to protecting people even with having budget cuts. We value our employees at Montgomery County Schools and we are looking forward to a very successful year. PDSA will be rolled out in its entirety this year. We appreciate everyone sticking it out."

With a motion from Bryan Dozier, along with a second from Shirley Threadgill, the board unanimously approved going into closed session to discuss personnel.

Superintendent Ellis welcomed everyone. The focus and review on School Improvement Plans will be included in the September board of education meeting. All related performance data aligned to the Strategic Plan is presented as part of our focus on accountability. The goal is for continuous improvement. This is an important part of the process to actually set up goals. Strategic Planning is the only way to meet the demands placed on schools today and to meet the needs of ALL children. Several goals were met and even surpassed, always, Mission, Venue, and Value MVV are very high as also the support for current direction.

Sue Hatley gave a review of globally competitive students which encompasses, the graduation rate, AYP, and ABC Expected Growth. The new online testing will not be ready per DPI this coming year as projected. Common Core will be fully implemented this year.

Kevin Lancaster gave an update of 21<sup>st</sup> Century Professionals/Healthy & Responsible which includes the goals for highly qualified percentage of NCLB highly qualified criteria, teacher retention, OSS suspension rate, and attendance rate.

Lindsay Whitley gave an update on leadership guides innovation, which includes goals for partnerships, and parent contacts.

Kathy Johnson gave an update on 21<sup>st</sup> century systems, which includes audit finding goals, maintaining an adequate fund balance, and adequate facilities.
