

**DOUGLAS COUNTY SCHOOL DISTRICT RE-1**  
**Resolution Authorizing Acceptance of Certain Dedicated Real Property**

WHEREAS, pursuant to C.R.S. § 22-32-110(1)(a) and (b), the Board of Education (“Board”) of Douglas County School District RE-1 (“School District”) is authorized to acquire, including by school site dedication, real property for any school purpose authorized by law; and

WHEREAS, pursuant to the plat of Sterling Ranch Filing No. 1 approved by the Board of County Commissioners of Douglas County (the “BOCC”) on January 29, 2015 (the “Plat”), certain real property located in Douglas County and more particularly described as Tract P, Sterling Ranch Filing No. 1 (the “School Site”) was dedicated to the BOCC to be held for a future school site; and

WHEREAS, with the voters’ approval of the School District’s bond on November 5, 2024, the School District is ready to construct a school on the School Site and has funds available to do so; and

WHEREAS, the Board desires to authorize acceptance of title to the School Site from the BOCC.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF DOUGLAS COUNTY SCHOOL DISTRICT RE-1:

**Section 1. Ratification of Actions.** The acquisition of the School Site is hereby approved. All actions heretofore taken by the Board, its officers, and agents, that were not inconsistent with the provisions of this resolution (the “Resolution”) and were directed toward the acquisition of the School Site are hereby ratified, approved and confirmed.

**Section 2. Approval of Action; Approval and Execution of Documents; Authorized Officers.** The Superintendent and Chief Operations Officer, and their respective designees, are hereby directed to petition the BOCC for conveyance of the School Site in accordance with the process set forth Article 10 of the Douglas County Subdivision Resolution. The President of the Board and the Superintendent are hereby authorized and directed to execute and deliver for and on behalf of the Board all additional certificates, documents, and other papers and to perform all other acts that they may deem necessary or appropriate in order to implement and carry out the transaction and other matters authorized by this Resolution. The Secretary of the Board or Assistant Secretary is hereby authorized and directed to attest the signature and acts of the President of the Board and the Superintendent in connection with the matters authorized by this Resolution.

**Section 3. Severability.** If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

**Section 4. Repealer of Measures.** All acts, orders, resolutions or parts thereof, in conflict with this Resolution or with any of the documents hereby approved, are hereby repealed only to the extent of such conflict. This repealer shall not be construed as reviving any resolution, or part thereof heretofore repealed.

**Section 5. Effectiveness.** This Resolution shall take effect immediately upon its passage.
