MINUTES OF THE SPECIAL PUBLIC MEETING HELD JUNE 30, 2021

The special public meeting of the Board of Education of the Vocational Schools in the County of Middlesex was held 1:00 p.m., Wednesday, June 30, 2021 electronically through Zoom.

On roll call, the following members were present:

Mr. Jones presided and made the following announcement regarding the "Sunshine Law."

RESOLUTION A: BOARD OF EDUCATION – APPOINTING INTERIM SUPERINTENDENT OF THE MIDDLESEX COUNTY VOCATIONAL AND TECHNICAL SCHOOLS

WHEREAS, the Middlesex County Vocational and Technical Schools will have a vacancy as to its Superintendent position effective July 1, 2021; and

WHEREAS, the Board of Education desires to appoint an Interim Superintendent on a per diem basis beginning on July 6, 2021 and continuing for a period of up to six (6) months or until such time as it has appointed a new Superintendent; and

WHEREAS, on June 23, 2021, the Board of Education conducted interviews of four (4) candidates for the position of Interim Superintendent; and

WHEREAS, on June 29, 2021, the Board of Education agreed to offer the position of Interim Superintendent to Robert Mooney pursuant to the terms of a contract which shall be approved by the Executive County Superintendent of Middlesex County; and

RESOLVED that the Middlesex County Vocational and Technical Schools Board of Education approve and authorize the appointment of Robert Mooney as the Interim Superintendent in accordance with the above resolution.

Ms. Czarneski moved, seconded by Mr. Mullen that the Board approve Resolution A.

On a roll call vote, Mr. Jones, Ms. Czarneski, Mr. Mullen, and Mrs. Eastman voted "aye," except Mr. Anderson abstained and the motion carried.


OTHER MATTERS
