- Dr. Ruth reported the following:
 - NCC recently launched the Interdisciplinary Healthcare Education and Workforce Development Center, funded by a \$2.7M federal grant. This state-of-the-art center fosters collaboration across nursing, respiratory therapy, and sonography programs, while also supporting two new accredited programs in cardiac sonography and respiratory therapy to meet the growing demands of the local healthcare workforce.
 - This summer, 14 NCC students attended an enriching study abroad trip to China, where they collaborated with JinHua University to immerse themselves in Chinese culture, architecture, cuisine, and daily life.
 - After a summer that saw credit hours grow 8% over last year, fall is trending positively, with current credit hours up 4.2%. NCC saw increases this fall in applications, new enrolling students, dual enrollment students and students living in residence halls.
 - ➤ NCC student, psychology major Amanda Alfaro, was selected as a national Coca-Cola Leaders of Promise Scholars this fall, receiving a \$1,000 scholarship. Scholars were selected based on outstanding academic achievement and demonstrated leadership potential.
