**MINUTES**

**Attendance**

A special meeting of the Bloomsburg Area School District Board of Directors was called to order at 7:00 p.m. on Monday, 7 October 2013, at W.W. Evans Elementary School, followed by the pledge to the flag. **RECOGNITION OF VISITORS & PERSONS WISHING TO SPEAK**

At this point in the meeting, there were no members of the audience who wished to address the board.

**NEW BUSINESS**

**Approval of Homebound Instruction Request**

Mr. Mael made the motion, which Mrs. Fiedler seconded, to approve a homebound instruction request for a Bloomsburg High School student, retroactive to 21 August 2013 and lasting for at least 20 school days. The motion passed by a unanimous voice vote.

**Approval of Change Orders for Pool and Generator**

Mrs. Fiedler made the motion, which Mrs. Rupp seconded, to approve as presented the change orders for the pool and generator projects. The motion passed by a unanimous voice vote.

**Approval of Field Hockey Booster Club**

Mrs. Rupp made the motion, which was seconded by Mrs. Crawford, to approve the Field Hockey Booster Club. The motion passed by a unanimous voice vote.

**Acceptance of Donations**

Ms. Kreisher moved to accept the following donations to the Bloomsburg Area School District:

- A monetary donation of \$500 from Merck to be used for prize money for the Bloomsburg Middle School Science Fair;
- A 1963 Bloomsburg High School dedication program by Representative David Millard;

- Coach Frank Golder's 1953 playbook by Jack Foust;
- A monetary donation of \$175 by the American Legion to the Bloomsburg Junior High Football Team to help with transportation costs to and from scrimmages; and
- The donation of a 1950s diner bar set piece and rod iron chairs, tables and platforms by the Line Mountain Arts Council to the Bloomsburg High School Drama Club.

The motion was seconded by Mrs. Fiedler and was then approved by a unanimous voice vote.

### **Approval of Out-of-State/Overnight Field Trip Request**

Mrs. Rupp made the motion, which was seconded by Mrs. Crawford, to approve the following out-of-state/overnight field trip request: Bloomsburg High School Student Council members to Boyertown, Pennsylvania from 14 November 2013 – 16 November 2013 for the purpose of attending the state conference, at a cost to the district of \$1,120.00.

Mr. Tobin then made the motion, which was seconded by Ms. Kreisher, to amend the motion to read: Approve the following out-of-state/overnight field trip request: Bloomsburg High School Student Council members to Boyertown, Pennsylvania from 14 November 2013 – 16 November 2013 for the purpose of attending the state conference, at a cost to the district of \$188.25. The motion to amend the original motion passed by a unanimous voice vote.
