III. Committee Reports

A. Board President's Report - Superintendent Search Update - Presentation by District Wise

President Maria Venuto introduced the superintendent search firm that the Board of Education plans to approve at this meeting. She welcomed District Wise, represented by Bob Freir, Joanne Kaplan, and Mark Kamberg, who introduced themselves and provided an overview of their process for selecting the next Superintendent of Schools for Glen Cove. District Wise previously facilitated the hiring of Dr. Maria Rianna, making them a familiar and trusted choice for the district.

The firm shared their approach through a PowerPoint presentation, acknowledging feedback and comments from the Board of Education. During the public comment section, audience members presented questions, which were addressed by District Wise.

IV. Superintendent Report

A. Updates

Dr. Maria Rianna spoke about regionalization and what some are calling "local control". Regionalization she explained is a state wide initiative asking school districts to complete a survey and then meet with district superintendents from their local BOCES to see if there are opportunities to share services or information with other districts that may enhance opportunities for some students and help share costs. With teacher shortages in certain parts of the state and shortages in certain certification areas, some districts don't have the enrollment numbers they need to be able to run certain courses, causing some students that graduate from high school to not get the opportunities that others get.

The State Education Department is asking to look and determine if there are ways to enhance the ability for those students to be involved in certain opportunities. It is understood that there is no mandate to share services, merge districts as well as not take away any district control for the services that they provide. Dr. Rianna will be bringing back updates and additional information from Albany where she will be in meetings over the weekend.

December 1st, is the date that the Rockefeller Institute is set to release its report on their finding in the foundation aid formula. We anticipate it providing recommendations for a new formula and we are hopeful that it will benefit Glen Cove. Dr. Rianna will share the findings and the next steps once they are received.

Dr. Rianna shared good news where she went on to say that as administrators they are always looking for ways to enhance student services as well as student post graduate. She was at a presentation today with representatives from Nassau Community College where they instituted several new opportunities that allows high school students to be enrolled in college course work. Not just dual enrollment but offer a senior year program that can result in obtaining an associate's degree by the end of the first year. Dr. Rianna stated that they will be meeting with the Dean of Nassau Community College soon so that they can best determine how these opportunities can be shared with our students. The Superintendent of Schools stated that Nassau Community College has been the number one college that students attend. The newest adventure that Nassau Community College has to offer is that it will be partnering with New York University Langone Hospital where the hospital will be building a satellite program on the college campus and their partnership will allow for internship programs in other areas other than medical. The best part of this is that in the spring of 2025 the college will be offering three price options for their students.

- **Option one:** if a district is a designated CEP (community eligibility provision) school, all the students in that district that qualify for free and reduced lunch will be able to attend Nassau for free (zero tuition).
- **Option two:** if a student lives in a CEP district and does not qualify for free and reduced lunch they will receive a 50% deduction on tuition
- **Option three:** students pay \$221 per credit.

Glen Cove is a CEP district and we would qualify for options one and two. Students don't just have to be going for an associate's degree, they can pursue many other degrees. Dr. Rianna along with Dr. Doeschner will be making an appointment with the dean to further discuss these opportunities.

Questions from the Board of Education were addressed.

1. New Course Proposal Presentation

Dr. Rianna introduced Dr. Alexa Doeschner, Assistant Superintendent of Curriculum/Instruction/Technology who presented via PowerPoint to the Board of Education going over all new course proposals for the next school year. Copies of the presentation were available for both the Board of Education as well as the audience.

Comments and questions from the Board of Education were addressed by Dr. Doeschner.

V. Student Board Member Report

Ms. Isabel Basil went over what's been going on in the high school. She congratulated the football team for making it to the semifinals of the playoffs where they were unfortunately defeated. Additionally, Shye Roberts, returned to the high school last Friday where a pep rally was held in her honor for her success on the Voice. The pep rally for Shye was a reminder as to how she continues to inspire and make our school community proud. Ms. Basil mentioned that a Veterans symposium was held a couple of weeks ago where students were given the opportunity to learn more about the experiences and sacrifices of our Veterans. She also mentioned that senior yearbooks and merchandise are on sale now. Isabel continued with the senior class volleyball fundraiser that she said was very successful and everyone had a good time. Ms. Basil included that her team won and they are planning on doing similar events in the future. Lastly, she mentioned the upcoming play "Almost Maine" that will be in performing this weekend.
