

**SHELTER ISLAND UFSD
BOARD OF EDUCATION**

**ANNUAL DISTRICT MEETING AND ELECTION
May 16, 2023**

The Annual District Meeting and Budget Vote for the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York was held at the school in said district on May 16, 2023.

At 12:00 pm, prevailing time, Tuesday, May 16, 2023, the Annual District Meeting and Election of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York, was called to order by the Board of Education President, Margaret Colligan.

President Colligan administered the Constitutional Oath of Office to the District Clerk Pro Tem, Inspectors of Election and Poll Clerks: Deborah Vecchio, Angela Corbett, Shirley Ferrer, Lois Corbett, Lew Corbett, Mary Gennari, and Luca Martinez.

The polls were declared officially opened at 12:00 pm, prevailing time and announced that they would remain open until 9:00 pm, prevailing time, for the purpose of voting by ballot for the Proposed Annual District Budget as presented for the fiscal year 2023-2024, the Proposed Increase in Mileage Limitation for Private School Transportation and to elect three (3) members of the Board of Education for three-year terms commencing on July 1, 2023 through June 30, 2026. (The candidate receiving the highest number of votes shall be immediately appointed to serve the remainder of the seat that is currently vacated (05/16/23 – 06/30/26).)

Proposition 1: Shall the Shelter Island Union Free School District Budget in the amount of \$12,664,093 for the fiscal year 2023-2024 be approved as proposed and the requisite portion thereof raised by taxation on the taxable property of the district?

Proposition 2: Shall the mileage limitation for the transportation of pupils to non-public schools be increased from 15 miles to 17 miles with the cost of proposed additional services to the district being \$102,498.12?
