Lead In Water Testing

Drinking water was tested at Northrup School on February 7, 2023. The testing was performed as part of our Lead in Water Safety Program and as recommended by the Minnesota Department of Health. The purpose of this program is to ensure that school drinking water does not exceed a permissible lead level of 20 parts per billion (ppb).

All water at Northrup School was collected on a first draw basis with a minimum of six-hour system stagnation. This method represents the worst case scenario for lead in water concentrations. A total of eighteen (18) drinking sources were tested (see attached lab report). Fourteen (14) samples collected were non-detected for lead in drinking water. Drinking faucets in classrooms 111, 112, 115 and the hallway drinking fountain at room 212 were identified with low lead levels well below the 20-ppb standard. As a precaution, these fixtures have been updated with a "lead free" components.

It is good news to receive test results identifying drinking source to be below the 20-ppb standard. However, because not all piping at Northrup School has been replaced with new piping, potential sources of lead remain; we have determined that the safest course of action is for Northrup School to continue its participation in the Lead in Water Flushing Program. EH&S has communicated the procedures for proper flushing with your Senior Custodian and the importance to perform these procedures daily. As a safe practice, EH&S recommends that all fountains be run until cool before drinking.
