

# Device Protection Plan for 21-22 School Year



Students enrolled in Beaumont ISD are assigned a district device and are responsible for all damages whether intentional or accidental. Responsibility for repair caused by a malfunction or maintenance issue will be determined by the Beaumont ISD I.T. department.

## Enrollment Information

The Chromebook Insurance Coverage Program is optional and provides an inexpensive solution for parents to reduce the financial burden if an accident or theft occurs.

Parents/guardians may decline to participate in the Device Protection Plan, but will be fully responsible for any associated cost for damage or theft. The Chromebook Protection Plan will cover one school calendar year (August-July) and is non-refundable and will not be prorated for a partial year.

Prior to receiving a Chromebook, the following must be completed

1. Complete the Beaumont ISD Chromebook Protection Plan enrollment form to select enrollment or decline enrollment.
2. If enrolled in the Device Protection Plan, pay the \$30 in full in the MySchoolBucks online payment system.

**Effective Coverage:** Immediately once enrollment is complete and fee paid in full.

**Expiration Date:** Device is covered until the last day of school or until the student withdraws from school, whichever comes first. If a student withdraws from Beaumont ISD the Device Protection Plan becomes null and void on that date. Devices not returned on the withdrawal date will be reported as stolen.

## Coverage - One incident per year from the following list

- **Accidental Damage** - Pays for one accidental damage caused by liquid spills, drops, cracked screens, or any other unintentional event.
- **Fire** - Pays for loss or damage of the Chromebook due to fire. The claim must be accompanied by an official fire report from the investigation authority.
- **Electrical Surge** - Pays for damage to the device due to an electrical surge.
- **Natural Disasters** - Pays for loss or damage caused by natural disasters.

## Exclusions

- **Dishonest, Fraudulent or Criminal Acts** - Will not pay if damage or loss that occurs in conjunction with a dishonest, fraudulent, or criminal act.
- **Intentional or Negligent Damage** - Will not cover repairs which are the result of intentional or negligent actions. This includes, but is not limited to the removal of keys, removal of outer rubber, removal of screws and/or opening the device.
- **No Case** - Students who do not use a case will be responsible for the full amount of the repair/replacement.
- **Cosmetic** - Damage that does not affect the functionality of the device. This includes but is not limited to scratches, dents, broken ports, port covers, asset tags and serial numbers.
- **Insect infestation** - will be liable for the full price of the device.
- **Loss** - will be liable for any device which is lost by the student.
- **Theft or Vandalism** - In the event of a loss or damage due to theft or vandalism a \$50 fee will be assessed. A police report must be filed within 48 hours and turned into the home campus. Failing to do so will require full payment of device cost.
- **"Jailbreaking"** or otherwise voiding the manufacturer's warranty by altering the software.

**Damaged Devices** - Devices in need of repair must be turned into the campus office. All repairs will be made by the Beaumont ISD IT Department and should not be taken to any alternate repair facility.
