SECTION #1: SCHOOL CHOICE CHANGES

- I. Current Elementary School Structure
 - a. History – Approved for the 2018-2019 school year, bus transportation was provided within each established cluster.
 - b. Clusters – Elementary schools were organized into 2 clusters
 - i. A: Centennial Arts Academy, Enota Multiple Intelligences Academy, Fair Street International Academy & New Holland Leadership Academy
 - ii. B: Gainesville Exploration Academy & Mundy Mill Arts Academy
- II. Proposed Elementary School Structure
 - a. Changes – Beginning in the 2025-2026 school year, there will be NO clusters and NO bus transportation provided outside each attendance Zone (Exception: Special Education & Homeless Students)
 - b. School Choice
 - i. GCSS bus transportation will ONLY be provided within a school's attendance zone.
 - ii. During the Choice Enrollment Window (January-February), a parent may choose a school outside the attendance zone, if space is available. The parent is responsible for transportation.

SECTION #2: ATTENDANCE ZONE CHANGES

- I. Reasons for Attendance Zone Changes
 - a. Enrollment & Housing
 - i. Centennial AA – Declining enrollment and minimal housing growth
 - ii. Enota MIA – Declining enrollment and minimal housing growth
 - iii. Fair Street IA – Increasing enrollment and increased housing growth
 - iv. Gainesville ES – Declining enrollment and limited housing growth
 - v. Mundy Mill AA – Increasing enrollment and increased housing growth
 - vi. New Holland LA – Declining enrollment and future housing growth
 - b. Housing Increase – More than 3,500 housing permits will be issued in the next few years. The map indicates the growth locations and the number of units.
- II. Attendance Zone Changes
 - a. For the table on the back of the paper, the roads listed are in the new attendance zone.
 - b. If your road is not on the table, your attendance zone will not change.
