The meeting was called to order at 4:30 pm by President Lynch, followed by the Pledge of Allegiance led by Brookelyn Gulluscio.

Kathleen Lynch read the following Shelter Island School Mission Statement – Engage, Explore, Empower:

We want our students to cherish our small Island community while applying and expanding their learning about, understanding of, and engagement with the wider world. To do this, they must be: ethical and moral individuals; respectful and responsible communicators; creative and analytical thinkers; knowledgeable and literate readers, writers, mathematicians and scientists; participants in and audiences for art, drama, music, athletics, and other artistic, cultural, and social activities; skilled and successful workers and consumers; and committed and active citizens.

2020-2021 Public Budget Hearing

Dr. Doelger welcomed everyone to the 2020-2021 Public Budget Hearing and presented a brief over view of the following topics.

- Proposed Expenditure Budget
- 3-Part Budgeyt
- State Aid
- Anticipated Revenue Budget
- Additional Propositions

At this time, Ms. Kathleen Lynch read the following statement.

We will now conduct a public hearing on the 2020-2021 adopted budget. The Board of Education has formulated a budget that is in compliance with the property tax cap and preserves programs for our students despite the economic times that are facing us. We are being faced with an unprecedented situation and I hope I can speak for my colleagues on the Board when I say that I am proud of our spending plan for next year.

Voters will be asked to render an opinion on this budget via absentee ballots, which are due back to the District on or before June 9, 2020 at 5:00 pm. Voters across the District should have already received, or are about to receive, their ballots in the mail. If there is a registered voter who has not received their ballot, please call District Clerk Jacki Dunning at (631) 749-0302 x101.

The Board of Education will open the floor to comments via the chat feature of this virtual hearing, but before that, are there any members of the Board of Education who have questions or wish to make comments?

At this time, Katherine Rossi-Snook highlighted Proposition 3, which is seeking authorization to use funds from a Capital Reserve Fund that was established in 2006 to renovate the science classrooms. Ms. Rossi-Snook noted that this money has been sitting unused for all these years and it would be beneficial to use it now to update the science labs.

President Lynch ask if there were any comments from the public that they wish to make at this time? Ms. Rylott was checking the support email and the comments section of the meeting and stated there were no comments at this time.

President Lynch then asked if any of her colleagues on the Board of Education have anything that they would like to add. No further comments were made.

Public Budget Hearing At this time, President Lynch reminded everyone to vote by June 9 and described how the votes will be tallied on that night -- at 5:01 pm on June 9, we will have four or five teams of two elections inspectors in the high school gymnasium each working on opening the affidavit envelopes. The envelopes will be separated from the ballots and the ballots will be shuffled to preserve voter privacy. The entire process will be live-streamed on the NFHS network -- the link will be posted on the district's website. All of our inspectors, including those who are District employees, have been trained in the proper administration of an election. We will count the ballots on June 9 and announce them on a Google Meets meeting at 7:00 pm – a link for this meeting will also be on the district's website.
