

**SHELTER ISLAND UFSD
BOARD OF EDUCATION**

**ANNUAL DISTRICT MEETING AND ELECTION
May 18, 2021**

The Annual District Meeting and Budget Vote for the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York was held at the school in said district on May 18, 2020.

At 12:00 pm, prevailing time, Tuesday, May 18, 2020, the Annual District Meeting and Election of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York, was called to order by the Board of Education Vice-President, Margaret Colligan.

Vice-President Colligan administered the Constitutional Oath of Office to the District Clerk, Inspectors of Election and Poll Clerks: Jacqueline Dunning, Shirley Ferrer, Lois Corbett, Lew Corbett, Betty Ann Morrirt, and Jane Richards.

The polls were declared officially opened at 12:00 pm, prevailing time and announced that they would remain open until 9:00 pm, prevailing time, for the purpose of voting by ballot for the Proposed Annual District Budget as presented for the fiscal year 2021-2022 and to elect three (3) members of the Board of Education; two (2) members for three year terms commencing on July 1, 2021 through June 30, 2024, and (1) member for the unexpired term commencing on May 18, 2021 through June 30, 2022. The candidates receiving the two highest number of votes shall be elected to the two full terms (07/01/21 – 06/30/24), and the candidate receiving the third highest number of votes shall be elected to the one unexpired term (05/18/21 – 06/30/22).

Proposition 1: Shall the Shelter Island Union Free School District Budget in the amount of \$12,384,947 for the fiscal year 2021-2022 be approved as proposed and the requisite portion thereof raised by taxation on the taxable property of the district?

No faculty/staff/community members assembled.
