The Annual District Meeting and Budget Vote for the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York was held at the school in said district on May 17, 2022.

At 12:00 pm, prevailing time, Tuesday, May 17, 2022, the Annual District Meeting and Election of the Shelter Island Union Free School District, Town of Shelter Island, County of Suffolk, State of New York, was called to order by the Board of Education President, Margaret Colligan.

President Colligan administered the Constitutional Oath of Office to the District Clerk, Inspectors of Election and Poll Clerks: Jacqueline Dunning, Angela Corbett, Shirley Ferrer, Lois Corbett, Lew Corbett, and Emmet Cummings.

The polls were declared officially opened at 12:00 pm, prevailing time and announced that they would remain open until 9:00 pm, prevailing time, for the purpose of voting by ballot for the Proposed Annual District Budget as presented for the fiscal year 2022-2023 and to elect two (2) members of the Board of Education for three-year terms commencing on July 1, 2022 through June 30, 2025.

<u>Proposition 1</u>: Shall the Shelter Island Union Free School District Budget in the amount of \$12,445,523 for the fiscal year 2022-2023 be approved as proposed and the requisite portion thereof raised by taxation on the taxable property of the district?
