PROJECT

This Invitation to Bid (ITB) is being issued by SCS for USAC eRate purposes. Satsuma City Schools (SCS) requests bids for the following category 2 networking equipment to add to existing equipment under the ALJP's Mini-Quote system. The network equipment in this request will be installed by district personnel. No setup or installation labor is required.

SCS is implementing a Meraki-based network infrastructure. Any solution or product must be 100% compatible and cannot affect warranty coverage of any other equipment. Integration with the Meraki Management Dashboard is highly desired and must include a 5-year enterprise license where applicable.

Equipment and quantities are listed in the tables below. Part numbers listed are representative of the desired equipment. Equivalent or better equipment can be proposed under eRate regulations but must meet all criteria of the ITB.

TERMS

- 1. Bids must be emailed to scochran@satsumaschools.com no later than 1/9/25, at 4 PM. Any bids received after the due date will not be considered.
- 2. As with all eRate ITBs, the district will, at its sole discretion, decide whether a vendor/respondent award will result from this ITB. The issuance of this ITB does not oblige the district to make an award.
- 3. No invoice will be paid until all purchase order items have been delivered to the school district's satisfaction.
- 4. Vendor must be an established business for a minimum of at least 5 continuous years and must have handled orders for the same or similar products.

- 5. Any agreement between SCS and the selected vendor will be contingent upon the availability of eRate and local funding, as well as board approval.
- 6. ALL awarded equipment should be delivered to the SCS Board of Education within 21 business days of the order being placed. Any delays in this timeline MUST be approved by the SCS District Director of Technology PRIOR to the order being placed by the awarded Vendor.
- 7. The aforementioned models or part numbers may be changed by SCS at any time AFTER Vendor is awarded a Mini-Quote if a different model will better serve the SCS network or if said Equipment will or could reach an End of Life (EOL) status within the current Academic School Year.
- 8. Vendor agrees not to "sell" or "sub out" any equipment or services contained within this mini quote once awarded.
- 9. Quote must include pricing for all hardware, licensing and other associated costs including a clearly stated Warranty.
- 10. This Mini-Quote is contingent upon award of eRate funds and SCS reserves the right to cancel and nullify any award if funds are not approved or local funding becomes unavailable.
- 11. Awarded Vendor agrees to wait for eRate match funds to be available.

EVALUATION

SCS will award based on the vendor submission that best meets the needs of the school system regarding the current Technology Plan, future growth, and ITB specifications, not necessarily the lowest price even though price will be a primary factor. SCS may elect to award all, some, or none of the services bid. SCS reserves the right to reject any or all of the bids or any items of any bids, to waive any informalities in bids received, and to waive technical errors in the best interest of SCS will thereby be promoted.
