Title I waa barnaamijkeed Federaalka ah oo bixiya lacagta dugsiyada iyo degmooyinka si ay u hubiyaan in dhammaan carruurta ay helaan fursad siman oo waxbarasho oo tayo sare leh, iyo in la gaaro heerarka waxbarasho ee dowladdeena. Xaaladda Title I waxay ku saleysan tahay tirada ardayda dugsigeena ka soo jeeda qoysaska dakhligoodu hooseeyo. Dugsigeenu waa barnaamij Title I oo baaxad leh, taasoo la micno ah in dhammaan ardaydayadu ay ka faa'iideysan karaan adeegyada aan bixino iyadoo la adeegsanayo maalgelinta Title I. Waxa na lagu waajibtay in aan u isticmaalno maalgelinta Title I si aan u horumarino guusha waxbarasho ee dhammaan ardayda iyo in aan ku dhiirrigelinno qoysaskeena habkan. Xubnaha shaqaalaha dugsiyada waxay la shaqeeyaan, iyagoo ka helaya talooyin waalidka iyo bulshada, si ay u diyaariyaan Qorshe Horumarinta Dugsiga. Ujeedada qorshahan waa in la hagaajiyo barnaamijka waxbarashada ee dugsigeena oo dhan.

WAA MAXAY XUQUUQDAADA SIDA XUBIN QOYSDIIN AH EE DUGSI TITLE I?

Waxaan rajeyneynaa in aad ka qaybqaadato hawlaha dugsiyada iyo waxbarashada carruurtaada. Waxaad heli doontaa macluumaad throughout sanad dugsiyeedka si aad ula socoto horumarka waxbarasho ee carruurtaada iyo horumarka dugsiyada ee ka dhiman caawinta dhammaan carruurta si ay u gaaraan heerarka waxbarasho ee sare. Waxaad heli doontaa casuumo si aad uga wada hadashaan oo aad gacan uga geysataan Qorshaha Horumarinta Dugsigeena iyo hawlaha ka-qaybgalka qoysaska. Waxaad ka heleysaa Qorshaha Horumarinta Dugsiga iyo Qorshaha Ka-qaybgalka Qoysaska boggeena internetka.

DUGSIGA TITLE I, WAA XUQUUQDAADA INAY:

- Codsato macluumaad ku saabsan shahaadooyinka macallinka/macalimiinta ama shaqaalaha kale ee dugsiyada carruurtaada.
- Ogaato sida dugsiyada carruurtaada loo qiimeeyo natiijooyinkiisa imtixaanka gobolka.
- Ogaato wax kasta oo xeerar ah oo ku saabsan ka qaybgalka ardayda ee imtixaannada khasabka ah.
- Ka filato isgaarsiin joogto ah oo lala sameeyo dugsiyada luuqadda aad dooratay.
- La shaqeeyso qoysaska kale iyo shaqaalaha si loo sameeyo heshiis u dhexeeya dugsigeena iyo qoysaskeenna.
- Ka caawiso qorsheynta sida lacagta ka-qaybgalka qoysaska loo kharash-gareyn doono.
- La shaqeeyso maallimiinta, qoysaska kale, iyo maamulaha dugsiyada si loo sameeyo qorshe ka-qaybgalka qoysaska.
- Codsato kulan la yeelato maamulaha dugsiyada ama macallinka carruurtaada wakhti kasta.

Codsashada macluumaadka ku saabsan aqoonta macallinka/kaaliyaha:

Shaqaalaha waxay ka go'an yihiin inay ka caawiyaan ilmahaaga inuu horumariyo xirfadaha bulshada, waxbarashada, iyo fikirka muhiimka ah ee uu u baahan yahay si uu ugu guuleysto dugsiga iyo wixii ka dambeeya. Ballanqaadkayagu wuxuu ka mid yahay hubinta in dhammaan macallimiinteena iyo kaaliyayaasheena ay aad u xirfad badan yihiin. Waxaad xaq u leedahay inaad codsato macluumaad ku saabsan aqoonta xirfadeed ee macallinka(yaasha) ama kaaliyaha(yaasha) ilmahaaga. Fadlan u dir codsiyada staffing@mpls.k12.mn.us. Kaaliyaha wuxuu bixiyaa taageero waxbarasho ama mid kale oo ardayda ah iyadoo si toos ah loo kormeero macallin. **Haddii aad codsato macluumaadkan, degmada ama dugsigu waxay ku siin doonaan macluumaadka soo socda:**

- Haddii macallinku uu buuxiyay shuruudaha shahaado iyo shati ee gobolka ee heerarka fasalka iyo maadooyinka uu macallinku bixiyo
- Haddii shuruudaha shahaado iyo shati ee gobolka laga dhaafay (looma baahna wakhtigan) macallinka, xaalad degdeg ah ama mid kale oo ku meel gaar ah
- Haddii macallinku uu wax ka dhigo maadada uu shahaadada ama shatiga u haysto
- Haddii macallinku uu buuxiyay shuruudaha shahaado, shati, diiwaangelin, ama shuruudo kale oo la mid ah oo ay aqoonsan tahay ama oggolaatay gobolka. Shuruudahan waxay khuseeyaan xirfadda xirfadeed ee uu macallinku ka shaqeynayo waxayna ka mid noqon karaan bixinta waxbarashada luqadda Ingiriisiga ee ardayda baranaysa luqadda Ingiriisiga, waxbarashada gaarka ah ama adeegyada la xiriira ardayda naafada ah, ama labadaba
- Haddii ilmahaaga uu helayo adeegyada Cinwaanka I ama Waxbarashada Gaarka ah ee kaaliyayaasha, aqoontooda.

MAXAA LOO INTIXAANAA ARDAYDA?

Waxaan imtixaan (sidoo kale loo yaqaan qiimeyn) ardayda si aan uga jawaabno su'aalo muhiim ah sida:

- Ardaydu ma baranayaan waxa aan ujeedo inay bartaan?
- Ardayda oo dhan ma horumarinayaan oo ma la kulmayaana caqabado ku habboon?

Ma kordhin doonno waxbarashada ardayda annagoo kaliya imtixaanaya ardayda. Saameynta imtixaanka ardayda waxay ku timaadaa sida macallimiinteenu u isticmaalaan natiijooyinka imtixaanka ardayda (sidoo kale loo yaqaan xogta). Xogta imtixaanka waxaa loo

isticmaalaa qayb ka mid ah milicsiga ku saabsan nidaamyadeenna iyo dhaqamadeenna heerka fasalka, heerka dugsiga, iyo heerka degmada.

MAXAY YIHIIN NOOCYADA KALA DUWAN EE IMTIXAANNADA AAN U ISTICMAALNO DUGSIYADA DADWEYNAHA MINNEAPOLIS?

1. **Imtixaannada mas'uuliyadda gobolka** waxaa loo isticmaalaa dhammaan ardayda si loo go'aamiyo haddii ardaydu la kulmaan heerarka heerka fasalka iyo si loo kormeero nidaamyada heerka dugsiga, degmada, gobolka, iyo federaalka.
2. **Shaashadaha Caalamiga ah** waxaa loo isticmaalaa dhammaan ardayda si loo go'aamiyo ardayda ku socda heerka fasalkooda iyo inay horumar sameynayaan. Waxaa sidoo kale loo isticmaali karaa in lagu kormeero xeeladaha heerka dugsiga iyo degmada.
3. **Qiimeynta Fasalka ee Soo Koobidda** waxaa loo isticmaalaa dhammaan ardayda si loo go'aamiyo haddii ardaydu ay barten xirfadda, bartilmaameedka waxbarashada, iyo/ama heerka uu macallinku bartilmaameedsanayo. (Tusaale ahaan, imtixaannada fasalka, imtixaannada dhammaadka cutubka, iwm.)
4. **Qiimeynta Baadhista** waxaa loo isticmaalaa qaar ka mid ah ardayda waxbarashadoodu hooseyso iyo ardayda aan muujinaynin horumar si loo aqoonsado xirfadaha gaarka ah ee ardaydaas u baahan taageero.
5. **Qiimeynta Kormeerka Horumarka** waxaa loo isticmaalaa qaar ka mid ah ardayda helaya faragelinta bartilmaameedka ah si joogto ah (toddobaadle, laba-toddobaadle, ama bille) si loo go'aamiyo haddii ardaygu uu sameynayo horumar ku filan natiijada faragelinta ku saleysan xirfadda. (Tusaale ahaan, caawinta akhriska.)
6. **Qiimeynta Fasalka ee Sameynta** waxaa loo isticmaalaa dhammaan ardayda maalin kasta si ay uga milicsadaan waxtarka degdegga ah ee waxbarashada hadda jirta iyo si loo go'aamiyo haddii ardaydu la kulmaan bartilmaameedyada waxbarashada maalinlaha ah.

IMTIXAANNADHEE AYAA LAGA RABAA GOBOLKA IYO DEGMADA?

- **Imtixaannada gobolka ee khasabka ah:** Minnesota Comprehensive Assessment (MCA) ama Minnesota Test of Academic Skills (MTAS) (3-8, Dugsiga Sare), ACCESS ama Alternate ACCESS (kaliya ardayda baranaysa Ingiriisiga), iyo ACT for All (Fasalka 10).
- **Imtixaannada degmada ee khasabka ah:** FAST ee K-9, Qiimeynta Luqadda Guud ee ardayda baranaysa Ingiriisiga, Istation ee ardayda dugsiga luqadda labaad ee K-5, iyo imtixaanka CogAT ee dhammaan ardayda Fasalka 2 iyo ardayda loo gudbiyo Fasallada 3, 4, iyo 5, iyo sidoo kale dhammaan ardayda Fasalka 5 ee aan horay u dhammaystirin imtixaanka. MA KU DHAHAYNAA 'MAYA' IMTIXAANKA?

Qoysasku waxay xaq u leeyihiin inay diidaan ka qaybgalka ardayga ee imtixaannada gobolka iyo degmada. Qoysasku waxay u baahan yihiin inay codsadaan foomka Ka-baxida dugsigooda, buuxiyaan iyagoo sheegaya imtixaanka gobolka ama degmada ee aanay rabin in ardaygoodu qaato, oo ku soo celiyaan dugsigu. Foomamka waa in la buuxiyaa sanad walba. Macluumaad dheeraad ah oo ku saabsan sida loo yiraahdo "maya" imtixaanka, fadlan eeg bogga 9 ee hagaha ay bixisay Waaxda Waxbarashada Minnesota.
