Funds will be used to address the spread of Covid 19 by having an additional space "isolation room" staffed by a certified nurse to evaluate Covid like illness in students and staff. Additional funds will be used to improve HVAC and ventilation needs in the building. Other funds will be used for cleaning and sanitizing the building following the most up to date CDC guidelines.

The Wildwood Crest School District will use the Fountas and Pinnell and the MAPS reading and math assessments to identify students that are behind grade level. These assessments will be used to track growth of these students in need of the interventions. These students will have access to targeted interventions during the school day and during a summer program for targeted grades. Students will also have access to an afterschool program that targets school work, homework, and study skills. The funds will be used to hire teachers to instruct during the after school and summer programs.
