Dear Parents and Guardians

I am writing to you today on behalf of the Board of Governors to confirm the School fees that will take effect from the 1st January 2025, following the recent Budget announcement on the 30th October 2024.

The Board of Governors have carefully considered the impact of this change and have done our best to minimise the increase in fees as we are mindful of the significant consequence this will have on the overall cost of education for many families. However, we are also committed to maintaining the high quality of education that we provide, recognising that this is why you have chosen to send your children to Bede's.

As per our letter of 20th September 2024 we have reduced the tuition and boarding fees for the Spring and Summer terms 2025. With the Government's requirement to add VAT at 20%, this will represent a total, overall increase of 16%.

The adjustments to the base fee and the overall impact will be as follows:

- **3.3%** reduction in the 2024-25 base fee from January 2025
- **16%** effective fee increase from January 2025, following the 20% VAT implementation

Please note that from the 1st January 2025, the fees for all 'extras', such as music lessons, drama, etc, with the exception of Transport and examination fees, will also attract VAT. Extras are generally charged in arrears, therefore, the charges on your Spring term bill will be for extras incurred during the Autumn term 2024 which are not yet subject to VAT.
